This, however, rarely happens, because the leaf is watched by skilled assistants, from beginning to end of the process. A few weeks after the leaf has been bulked the heaps already described are said to b " cured," and are ready for packing and shipment.

A significant fact connected with thi celebrated brand can be found in the Tables of Trade and Navigation. It will be found there that the tobacco leaf imported into the Province of Quebec passes through the Customs at an average price of seven cents per pound, while the average price of the import into Ontario-Messrs. Tuckett & Billings receiving the greater part of it-passes through at an average cost of fifteen cents per pound. These official figures reveal the whole which aims to supplant the Myrtle Navy.
