

that of the previous year, notwithstanding the withdrawal of the Special Dominion Subsidy and of the interest on Albert Railway Subsidy fund account.

He would now turn to the items of expenditure of 1877, which required explanation. It must be remembered that there was an exceptional expenditure of \$50,000 for the Normal School building, and that the summer session, necessitated by the St. John fire, cost the Province \$7,240.99. There was a Lunatic Asylum charge, also, of \$1,000 over the estimate, and education expenditure was \$1,143 more than was expected. Of course. the \$4,000 granted for the Agricultural Exhibition was not expended. The redemption of debentures cost, as estimated. \$10,000, though the sum required to meet interest on debentures was less, by some \$2,000, than estimated, because the railway companies had not proceeded with construction quite so rapidly as was ex-pected. Under the Free Grants Act, \$1,166.41 more than estimated was expended, while all the other items of expenditure either just equalled or fell under the estimate. The total Current Expenditure, therefore, was \$621,324.62 against an estimated expenditure of \$594,509.91. In addition to these there were the Bear Bounty item provided for by Statute. \$1.869: School Loans made in 1877 \$21,837.24. The estimate for Public Works was 481.13. The whole of the latter sum. however, was not expended on account of services of 1877, but included some \$15,-000 over expended in 1876 on roads and bridges.
