GREAT LOSS OF CATTLE AND HORSES-OUT where the settlers were with difficulty LAWS AND THEIR DOOM.

New Westminister B. C. 29th Mar. '80. To the Editor of the Miramichi Advance. DEAR SIR:-The winter just drawing to a close has leen the most severe that British Columbia has experienced for many years; indeed, it is unprecedented in the memory of the "oldest inhabitant," or according to any records extant.

THE LOSS OF STOCK in the upper country has been enormous, and many stock raisers have been reduced from affluence to poverty, through their imprudent dependence on the weather, having made no preparations for housing their cattle, and thousands have consequently perished in the snow. The Indians of the interior have also been severe sufferers, the majority of their horses having literally starved to death. Previous to last week there was no river communication with the upper country since December last; the river being

The monotony of life here has been somewhat disturbed lately by a trial of exceptional interest and importancenamely, that for murder of "the Kamloops outlaws," three brothers named McLean (Allan, Charley and Archy) and one Alexander Hare. These parties, for some time past, had carried on an organized system of plunder and terrorism throughout the neighborhood in which they lived, which culminated in the murder of a constable named Ussher and a sheep herder named Kelly, for which crimes each and all of them have been sentenced "to be hanged by the neck till they are dead These "outlaws" are half-breeds, and

with one exception, are mere boys, the youngest McLean being but fifteen years old. The father of the McLean brothers was a "chief factor" of the Hudson Bay Co., and a man of undaunted courage.
