A recent decision of the Supreme Court of Massachusetts establishes the fact that open bars are illegal in that State. - Tele-


Em-bar-rassing.

The Supreme Court, or the Telegraph ought not to announce such decisions as the above, because they are perplexing. If sand bars are meant the decision is unquestionably against the interests of navigation and commerce ; if quilting bars, an old and popular occasion for party-giving in the country is directly attacked ; if music-bars, we may expect the Massachusetts Supreme Court to be the subject of a comic opera in the near future : if the bar which fails to pluck half-qualified stu. dents, the Bay State Court has done itself credit and set an example worthy of imitation ; if Scott Act bars, the decision is worthless; if iron bars, it is meaningless; if bars of soap, they can be packed closely without difficulty ; if fence bars, the Court is right and the man who leaves them down cannot claim damages. In fact, if the Court or the Telegraph were more perspicuous it would, perhaps, not be difficuit to determine whether the decision was right or wrong. What kind of bars are illegal when they are open, anyway? The Court ought to explain.
