FIVE TRIPS A WEEK.—Until further notice, the steamers of the International Steamship Company will make five trips a week between Boston and St. John. Steamers will leave every Sunday and Thursday mornings at 8.30 o'clock, touching only at Eastport and arriving in Boston early the following morning. On the return trips the steamers will leave Boston on Tuesdays and Saturdays at 8.20 a. m., arriving in St. John early on Wednesday and Sunday mornings.

RETURNING OUR SALMON FISHERIES.—A gentleman who recently went up the Southwest River salmon-fishing, reports that he found a net with a gill-net-pool attached to it stretched all the way across the main Renous at Colpough's. It was impossible for any salmon to pass this obstruction. How is it that the paid officers of the Fisheries Department cannot detect and secure the punishment of such gross violations of the law as this?

Enquiries by the same gentleman developed the fact that no less than fifty fish were netted out of the pool at the mouth of the North Branch of the Renous. He saw the evidence of the slaughter on the ground in the way of scales, offal, etc. We can furnish names if necessary, but, then, the Department don't care.

THE POLICE COURT of Chatham is a very officious place from a sanitary point of view, owing to the fact that the cells, which are entirely unventilated, open directly into the court room through which their effluvia passes. The Chatham Board of Health might make a beginning in the way of performing their duty, by visiting this building and taking such action as its condition demands. There are few towns in the Dominion, we believe, where the police authorities would be permitted to confine prisoners in such stench-laden cells, for in the law-breaking classes have their rights, and whatever their acts may be, ought not to have their health needlessly endangered. The police court should also be held in a well ventilated room, properly arranged for the convenience of those officially concerned

with it, as well as for those who may be present as mere observers of the proceedings.

Burglary.—A young man who gave his name as Joseph McGraw was committed for trial on Monday last by G. A. Blair, Esq., Police Magistrate, on a charge of breaking and entering the store of George Barchill & Sons, Nelson, on the night of May 30th and stealing therefrom a silver watch and other property. On the silver named a panel was broken out of one of Messrs. Barchill's store doors, and an entrance thereby effected. The watch and other goods, together with some change, were taken. McGraw left the watch at Mr. Myer Moss's establishment next day for repairs and on his calling for it on Saturday last was arrested by Police Magistrate Blair for whom Mr. Moss had quietly sent when the suspected party presented himself. He said he had purchased the watch from a man in Moncton, but offered no proof of the fact when under examination. It appears that McGraw was working for Mr. Sargent at the time of the robbery and the fact that some of the stolen property was found concealed in that gentleman's barn is suggestive.

An ex-Fish Culturist vs. the "Advance".

GASPE, July 9th, 1883. To the Editor of the Miramichi Advance. DEAR SIR,—Having been down here last month putting up a few Gaspé salmon I did not get the ADVANCE, having neglected to order the address changed. I have now, however, your issue of the 5th before me and note your editorial on Mr. White's letter. Of course you advise shutting up the ruinous fisheries. As you are aware, my connection with pisciculture ceased a year ago last April, and I have no axe to grind, but would ask, why was Miramichi so far ahead of other rivers last year in its salmon supply. You admit the poaching is fearful. Smoked gravid fish by the ton. Why is it that the salmon catch the last two years (and this also) is so much less on all rivers which developed them? Take the Nepisiquit, and other rivers on the opposite side of Chaleur Bay, take Labrador rivers, St. John, Moisie, Natashquan, and the salmon catch is nearly nil. Restigouche, this year has surpassed the whole in both netting and angling. Metapedia pool alone had a record last week of 280 fish, 5,600 lbs. Sage and Lawrence for a couple of weeks caught 190 fish averaging 24 lbs, John Wilmot and party in 3 weeks at Indian house killed some 200 salmon, 80 of which fell to the veteran's own rod. As for the netters, the coast-catches below Dalhousie, where the lovely pasche reigns supreme on stands from 2 to 3 hundred fathoms long, are something beyond belief, from 10,000 to 20,000 lbs being reported as a single net's catch, while on the main Restigouche the anglers report the fish telling one another to "lie over". Fine fishing has also been had on Gaspé rivers and the netters catch has more than doubled last year. I think these facts, not on paper—yes, I beg pardon, bank notes—go to show that the fisheries have not entirely ruined the rivers, and I beg respectfully to point out to the New Brunswick Inspector these facts as the results of a few of those abominable hatcheries.
