It is now said that the Dominion Government has referred to the Local Government the matter of the Shippegan mail outrage, on what grounds, however, we have not learned. It is probable that the strong influences brought to bear on the Dominion Government for the purpose of saving the offending Sheriff from the consequences of his high-handed act, have had the effect of suspending the uplifted arm of justice and giving assurance that the laws' penalties are only intended to be inflicted on the uvinfluential and ignorant. It is as good as saying to such men-"So long as you can retain the political influence of Messrs. so and so and are willing to be handled by them. and so long as they stand by us, just so long may you defy the laws and outrage the rights and privileges of your fellow-citizens."

The Dominion Government having asked the Local Government to deal with the matter, what does the latter say? Are the same influences that operated at Ottawa to prevail at Fredericton ? We presume the Ottawa Government has made enquiries and established the guilt of the offender. and that the evidence is now officially before the Attorney-General of the Province. If so, the matter is not one over which he can long hesitate. He knows that a man who commits the offence proved against the Gloucester Sheriff is unfit for the high office held by that person. Besides, there are other evidences of the Sheriff having sympathies which do not tend to invite respect for law or discourage criminals of a certain class.
