The Beer and County Assessment Cases.

A Fredericton despatch of the 14th gives the following judgments of the Supreme Court on cases arising out of the Se tt Act, the decisions in both cases sustaining the prosecution :-

Ex parte Chas. Cassidy-This case is better known as the Chatham hop beer case. The attorney general appeared to support the conviction. Mr. Geo. F. Gregory, who had obtained the rule, said that the whole point involved was whether or not there was evidence that the beer was intoxicating and he produced the affidavit of witness to show that he had not sworn that the beer was intoxicating ; but a the case fell within Daly's case in when a decision had been given since the granting of this rule, and in which the court held that want of evidence of the offence was no ground for certiorari, and so long as that judgment stood he could not support the rule. The rule was discharged.

Ex parte John Jardine-Case relating to assessment in Northumberland County for payment of Scott Act Inspector. Mr. Blair, attorney general, shows cause against a rule nisi for certiorari granted by Mr. Justice Palmer in June last ; no the appears to support the rule. Rule discharged.
