The Manitoba department of agriculture has issued a bulletin on the condition of crops and live stock; 378 correspondents reported simultaneously that the weather was admirable for seeding. Growth was slow early in the season, but

very rapid later on. The average fall of rain over the whole province has been 1.79 inches and only a few places reported as needing any. The acreage under crop was 1,053,263, an increase of 160,000 over last year. The condition of grain, root and hay crops in almost every district is reported excellent. The prospects for a bountiful yield were never more promising. Live stock also is in a flourishing condition.
