THE FAMED FOOD PIT. The Food pit at Stellarton, which has been filled ever since the great explosion some ten years ago, is now almost ready for being worked again. The Enterprise says: "The brick arches are nearly complete. The 1 1/2 ft north side is 480 ft, on south 180 ft. This work consumed over one half a million of brick and a large quantity of Portland cement. The arches are strengthened with heavy rails bent to a radius of nearly 33 ft, on a 10 ft span. As the arch will be built in cribs six feet in length, thirty feet in breadth and sixteen feet in depth, the construction of the cribs is being superintended by Mr. Leary's foremen and efforts will be made to put them together so firmly that they will withstand the heavy weather and rough sea off the coast of Maine and C. P. Co. The sixteen cribs will be fastened together with heavy wire rope and seventy-five feet has been fixed as the distance between each section of the raft. This will make the length of the raft 1,200 feet. One large raft, or considerably over half a million, has been ordered by the Lewis Luckenbach and Edgar F. Luckenbach, started yesterday for Nova Scotia to tow the raft to this port—Brooklyn Star June 26th.
