





Up to 1874 the revenue of the province met the expenditure very fairly, but in that year a railway subsidy act was passed which was only the precursor of others by which the bonded debt had been piled up. He was not going to find fault with the government of that day for passing that act. They were forced into it by their supporters, and the latter FORCED INTO IT BY THE FEOPLE.

It has been said that under the subsidy act of 1882 the government was only bound to construct 250 miles of railway. To his mind this was the sheerest nonsense. Both of these acts referred to were matters of compromise, and it was impossible to erect roads in one section without other sections getting their proper propertion. Every part of the province had an equal right to railway facilities.
