

Poor U. S. Crops.

The October returns to the statisticians of the United States department of agriculture makes the general condition of corn 71.5 agaiust 74.7 for last month, and 791 October, 1892. This falling off in addition is the result of the continued drought which has prevailed since June and was not broken in the corn belt until the latter end of September. The returns of yield per acre of wheat indicate a production of about 11 3 bushe's, being 1.7 bushels less than last October's estimate. The average vield of oats as consolidated is 23 5 bushels against 24.3 last year. The last report of condition was 74.9 agaiast 78.9 the same month last year.

Certain resident gunners have stuck small spruce trees down into the bottom on the feeding grounds to form blinds, in which they place their canoes or gun-floats, and these objects have had the effect of frightening the birds away-thus materially damaging the bay as a resort for wild geese especially.






