

conquest in 1169 until the right of self-government for the Irish people

subordinate to that of Great Britain, owing to the English Privy Council having the right to decide what laws should be passed by the Irish Parliament. This boon was obtained in 1782 when Henry Grattan, in Parliament, moved his famous Declaration
