Miramichi Advance. CHATHAM, THURSDAY, MARCH 22, 1877. AN ACT RELATING TO MUNICIPALITIES.

14.—The election for Councillors shall be held annually in each Parish on the last Tuesday in October.

15.—No election of Councillors shall be held in a tavern or in a house or place of public entertainment.

16.—The meeting for any election shall begin at ten o'clock in the morning.

17.—The nomination of Candidates shall take place prior to eleven o'clock in the forenoon.

18.—If any more than a sufficient number of candidates be nominated and make the required declaration.

19.—Unless otherwise provided every male British subject of the age of twenty years.

20.—Each Collector of Rates shall at least ten days before the day for the annual election.

21.—In the Parish of Woodstock in the County of Carleton.

22.—It shall be the duty of the Collector to attend personally, or by deputy as hereafter provided.
