As the north-bound express train on th Intercolonial Railway was running at its usual high speed within some two miles of Salisbury on Friday evening last, the engine struck a buggy which was being driven across the track at Anderson's crossing. Those on the train soon knew that the mishap was a serious one as one, of the buggy. wheels was carried along on the forward part of the engine. The train . was backed to the crossing, where portions of the wagon and its contents were seen scattered about and, by the roadside, was a woman in a dazed condition, with blood-smeared face. She had been picked up by section-foreman Anderson and was soon able to give an account of herself, although suffering from a scalp wound and evidently much injured in the left side, near the hip. Everything that kindness could suggest was done by the train men and passengers-among the latter being Capt. Smith, R. N. R., Mr. W. B. Snowball and the editor of the ADVANCE. She was lifted and placed as comfortably as possible in the Puliman Car, whe e her head was bandaged and the blood washed from her face. She said she a married woman 58 years old named Ryder. She was on her way to Canaau, some eight miles from the crossing. She neither heard nor saw the train until it struck her. She expressed herself as being very grateful to the train people for running back for her, but seemed to be under the impression that she was fatally injured. She frequently enquired about the horse, but the animal seems to have escaped uninjured, as it ran away, section foreman Auderson having seen it doing so, and it was going back in the direction from which it had come, instead of towards home. The shock of the collision had evidently stripped the harness off the borse, for the collar was broken apart at the bottom, almost as if cut with a knife. The wagon was broken in small pieces, and the general wonder was that Mrs. Ryder had escaped alive. When the train reached Salisbury she was carried to the station and left in the care of Dr. Moore.



Mr. Boudreau opened the discussion with a few well-timed remarks.
