Under the judgment of the Judicial Committee of the Privy Council and the remedial order they certainly have important legal rights in counection with separate schools, and while the Domin ion Parliament may have jurisdiction to en force some or ail of those rights, it is universally acknowledged that this could be done with more advantage to ail parties by the Local Legislature, and for this reason we are holding this conference. A discussion of the disadvantages of separate schools is, therefore, in our view not relevant to the pre sent situation, and is likely to raise misleading issues. In our view much of your argument misses its mark because you have not recognized the present position of affair and dealt with our suggestion as compared of the propositions which you make would with a regular system of separate schools such as might be established under the Remedial Bill, or under the old system, bu have rather confined your attention to maintaining that our proposition would involve some of the drawbacks of these other schools. We deeply regret that you have felt obliged to reject our proposition, and with all deference it does not appear to us that the objections, general and special. which you urge are such as to necessaril involve so serious a step. 



"As to the first of these objections, we may observe that the separation of the Roman Catholics as a class does not arise from our suggestion. It is made by un constitution and arises as to them becaus they happen to be a minority of the popu-lation. It is inaccurate to say that any privilege is given to them as against the rest of the population. It is only the righ conferred on the minority by the constitu tion that are in question. The poblem presented in the school question is to secuto them their just and lawful privilege noder the constitution in such a manner a to cause the minimum of interference wit the public school system of Manuoba, a d in that view we think that our suggestion has merits.
