

earth and he pointed out how he had done so by conquering all other living things and overcoming the forces of nature. Referring to the opportunities of nations to overcome the darkness of heathenism he instanced the failures of Portugal and Spain to do God's work and showed that Portugal was now the smallest of nations, while Spain had "shrun s into her shell like a shrivelled nut." Then, he pictured E aland's work in christianizing the world and pointed to her reward in her great possessions and position as the greatest power of the earth. He concluded by introducing




