**How Dioulafoy Lends Piquancy to Parisian Life**

There are but three or four ladies in France who have availed themselves of the benefits of that law which provides that women may wear male attire on obtaining a permit from the authorities, which can be had for a merely nominal fee if valid reasons are given. One of the applicants wishes to wear male garments. Among these few ladies, Madame Dioulafoy, the wife of the well-known explorer and orientalist, is certainly the most interesting. Like Lady Burton she accompanied her husband on his voyages and in order to avoid the unpleasantness always experienced by women when traveling in Oriental countries, as well as for better protection, she adopted the costume of a man, being of a very slight build. When Lady Burton on her return into civilized countries resumed the garb of her sex, the French traveler kept up her habit of wearing the male costume she had grown fond of. This is to-day frequently seen in the literary and scientific society of Paris.  
 Not long ago a German journalist requested an interview of Madame Dioulafoy, whom he had never seen, and received a very gracious reply to call the next day. He must evidently have been under the impression that she only wears male attire when going out with her husband, or in the case of a very slight build. When she was introduced to him, she was in her own words, now so much in use by Parisiennes at their homes. When entering her boudoir, a charming room with a carpeting of old oak and blue cloth draperies, she sat down in a high-backed gentleman stretched in an easy chair with the feet toward the open grate, in which a log fire was burning briskly. The reporter became confused at seeing an apparently young man, where he had expected to meet a lady of mature years, and stammered: "Beg pardon, sir, I requested the honor of meeting Madame Dioulafoy." Upon the little monsieur replied smilingly: "Why, that is I, even the visitor was dumfounded, and in his own words we state his experience: 'I could not for the moment stammer an excuse, nor an explanation. I mechanically adopted the dress of a man and sank into it. In silence I attempted to collect my senses, to re-establish my presence of mind. I stared at her, and all I know is that I continually repeated to myself the words: "And that is a woman!"'  
 Mme. Dioulafoy was faultlessly attired. She had just returned from a wedding. Her Prince Albert coat, closely buttoned, fitted her form wonderfully. It did not reveal even the slightest trace of female shape. A chamamois colored waistcoat and a well fitted blue bow could be seen above the coat; her trousers—thanks to God, the word is not in French—were of a pearl grey cloth. She wore patent leather shoes of the broad-heeled English pattern. Her brown hair was cut short and brushed back smoothly like those of a man and not curly like those of a woman. Her face was rather pale but expressive, and her piercing grey eyes seemed to penetrate into the inmost recesses of mine. I have seen many chess players who look like her, but I never saw anything theatrical or constrained about her. While I was perplexed and could not even speak coherently, she, like a true woman of the world, kept up the conversation as if she were not feeling that she noticed my surprise. She was very much at home in her peculiar attire and looked quite serious, almost too serious."  
 Madame Dioulafoy accompanies her husband everywhere in the costume she has adopted for good, but this often results in very comical episodes. Not so very long ago they attended an evening entertainment at the Casino de la Gaiety, the fashionable set. The "porteur" (attendant at the door) who was to announce them, received their card, which read: "Monsieur et Madame Dioulafoy." He looked at the card, then at the strange couple, finally he turned to the door in dismay and called in: "The two Messieurs Dioulafoy," much to the amusement of everybody who knew them.

**The Cuban Trochu.**

The war reports from Cuba have a great deal to say about the trochu. It is a new term in military science, and there is more or less confusion in the public mind as to what it means. In a sense, it signifies a strategic line across a given scope of territory, separating one army from another. The line in the present instance extends from Havana to the southern coast of the island and its original purpose was to divide the insurgent forces, part of which were in the western portion of the island under Maceo, and the rest in the eastern portion under Gomez and Garcia. It consisted principally of a barbed-wire fence 3 feet 6 inches high, with sentry detachments immediately behind it. And about forty yards back of it is a trench three feet wide and four feet deep, with a breastwork of palmetto logs; and fifty yards further back are log houses in which the troops are quartered. The number of soldiers required to guard the whole line is about 15,000. It was the Weyler's idea of comprehensive and effective strategy, and he is said to be very proud of it.—St. Louis Globe-Democrat.

**Bran a Substitute for Coal.**

Because of the excessive rates charged for coal, various schemes are concocted throughout the State of South Dakota to secure some sort of a substitute for coal. The roller mill at Kimball, that State, is doing its share in this regard, the roller mill instead of coal being utilized for fuel. As it would be impossible to feed the furnace in the ordinary way without endless toil, Engineer Perkins invented an ingenious contrivance that feeds the bran to the fire-box automatically. The contrivance holds the steam gauge to 80 pounds for hours at a time without regulating.

**CHRISTIAN OR ROMAN?**

**Human Remains Dug Out of the Gravel in England.**

An interesting discovery has been made near Horwcastle, England, says a correspondent. In the outskirts of the town Mr. G. W. Smith, seedsman and greengrocer, was employing a laborer to dig gravel for his premises. About two feet below the surface the man's pick struck against something hard, which on investigation proved to be a leaden coffin. It was imbedded in the gravel, and proved to be in a fairly good state of preservation. The sides and ends, however, had lost cohesion between themselves and the lid, the latter being also broken in the process of uncovering it. Owing to this want of cohesion the soil had fallen in and filled the interior. This was carefully removed, when there was disclosed to view a perfect skeleton, since preserved by medical experts to be that of a female. The coffin was five feet 2 inches in length, the body, of course, being rather shorter. Last week, as the gravel digging was continued, a second leaden coffin was exhumed about a yard to the north of the former. This was in very much the same condition, the lid only being rather more broken in extricating it. This coffin was five feet 7 inches in length. The bones were large, and are pronounced to be those of a male. Some twenty-four years ago three leaden coffins were found within 100 yards of the same site while workmen were digging with a view to taking and foundation of a nonconformist chapel. No care was taken of these, and they were disposed of as old lead. Several Roman cinerary urns have been dug up at different times in this locality, as well as many Roman coins and other antiquities. The main question is: Were these lead coffins Roman or Christian? On the same site of the town there is a public recreation ground called "the field." Were they Saxons? From their lying east and west the correspondent is inclined to consider them Christian. Their somewhat rude construction, and the absence of any kind of inscription, also incline him to suppose that they were originally inter "sacris" inclosed in a wooden exterior, but no trace of decorated wood was perceptible.—Boston Herald.

**The Peanut.**

From all appearances the plebeian peanut is not properly appreciated in this country, as it is in Europe. In Europe this nut has various uses which are only beginning to be recognized in this country, the first recognition being that of a Virginia company which brands the peanut as a product. According to the Manufacturers' Record the principal products are peanut oil for cooking and table purposes and confectioners' use, peanut brittle for confectionery, peanut grits for soap, and peanut meal for making and bran for stock feed. The oil is highly valued in Europe, and it is stated that fully \$5,000,000 worth of peanuts are brought into this country annually for the manufacture of oil, which is used in toilet soaps and for other purposes. The peanut flour is quite extensively used in Europe and made into bread, cakes, biscuits, etc. It is one of the favorite articles of food, according to consular reports, in hospitals in Germany.  
 The estimated product of five tons of peanuts amounts to 235 gallons of refined oil, at \$1 per gallon; 175 gallons of oil at 50 cents; 368 pounds of flour and meal at two cents, and 2300 pounds of stock feed at 60 cents per hundred pounds, making \$45.90 in all.  
 In the mechanical handling of peanuts they are first crushed and cut between suitable rollers, then the cut and crushed mass is submitted to a not for separating the shells and kernels, and finally drying the kernels to separate them from their skins.

**The Age of Trees.**

The annual, or ring-growth, of trees and their relation to the age of the average specimen of the "forest monarch" has been the leading subject of discussion in the scientific journals for the past two months. It is pretty generally admitted by the forestry experts that the "tree ring" as it is called, can be properly applied, the age imputed to the tree will not err in the way of excess. It is so admitted by the very best of the great best of writers upon this subject that a clearly-marked ring infallibly denotes a season's growth. Assuming, then, that these growths are true age indicators, it is plain that where there is an unusual year, or perhaps, an unusual year, one year's credit will remain unentered in the tree's life register. On this ring basis of computation a German scientist has been engaged in preparing a table of the ages of certain European trees. He finds that in Finland and Sweden the pine and fir trees attain to the maximum age of 700 years. The greatest ascertained age of the larch (this is Bavaria) was 274 years, while the silver fir of the same locality often grows until after it is 400 years old. The oldest known German specimen of the oak is one of the "holm" variety, which formerly stood near Aschaffenburg, which the ring growths proved to be 410 years of age. The maximum ages of other German trees—as formed by counting the ring growths—is as follows: Red beech, 245; ash, 170; elm, 130; birch, 200; aspen, 210, and alder, 145.

**Ten Thousand Miles in 53 Seconds.**

How much actual time is necessary to transfer a telegraphic message from London to Valparaiso, Chile, was the question propounded by some South American editors last summer. The reply was furnished by a special communication, when an arrangement was made with the telegraph and cable companies to keep open wires and test the telegraphic results of a recent sporting event to Valparaiso with the least possible delay at the intervening stations. Ten minutes before the message was sent the wires were cleared along the entire distance and all the ordinary communications through the cables were suspended. At the given astronomical time the despatch was sent from London to Cavalleros, when the message was transferred through a submarine cable to Pernambuco, wherefrom the Brazilian coast cable conducted the message to Buenos Ayres. It was from there despatched over the South American Transcontinental telegraph line and arrived at Valparaiso 55 seconds after leaving the London office, although the distance it had to travel in this short space of time amounted to almost 10,000 miles, and the eight words of the message had to be repeated four times.

**Smallpox an Old Disease.**

One of the oldest actually specified diseases would probably be smallpox, which was first mentioned by the Greeks as having attacked the African tribes who made excursions into Arabia and laid siege to Mecca in the latter half of the sixth century, A.D.
