

say it is supposed to be a disease, for it is at best but a mere supposition, as no such disease does exist. It is properly speaking a peculiar condition of the mouth, which every colt is not only subject to, but really must have, just while the second growth of the front teeth is taking place, and before they become sufficiently long to project beyond the gum and roof of the mouth, particularly that part which is just behind the row of cutting or nipping teeth. While the mouth is in this state it is of course difficult for the colt to bite off the grass in a poor pasture easily enough to keep in good condition, and consequently he loses flesh; and in addition to this, he is made to work, (as many are at this age) without any better feed than a short pasture affords, he dwindles away to a mere skeleton, and his owner thinks it is because he has the Lamper, and he treats the animal accordingly. That is, he gets a hot iron, perhaps made on purpose for this operation, and burns out the roof of the mouth till the teeth can be brought more nearly together; the colt is now turned out till he may have time to recover from the disease, and if he is put into the meadow or orchard, as he often is on account of his sore mouth, he will thrive well enough—simply because he gets plenty to eat, and nothing to do—and the disease is thus thought to be cured.

Now the nonsense of the Creator inflicting upon all the horse kind a disease which needs the interference of man ought to be plainly seen by any one; and the incorrectness of such a supposition is shown by the fact, that the numerous droves of wild horses which roam over the western prairies, are never known to fall away from the effects of lamper, and for the simple reason that at the time, when the new teeth are yet too short to nip the grass on a bare sheep pasture, they have plenty of long grass to keep them thriving.

This process of burning or tearing out the gums of a colt is quite as cruel as it is useless; and if the owner will, instead of this, put the animal into an inclosure where there is plenty of grass, or if he will give him oats, or some ground fodder, we will be answerable for the success of the treatment. We speak with confidence for we have seen the experiment tried and proved its value; and we speak with some degree of interest, for we have uniformly found that noble animal would perform his part more ably and cheerfully when well fed and kindly treated, than under the most approved system of starvation and cruelty which could be devised.
