The Head Quarters is down upon the Post Office Surveyor because there is no Mail to leave St. John from Friday evening until Monday evening during the winter, and none to be sent from Fredericton after Friday evening until Sunday evening; also for compelling the Post Master at Fredericton to open his office twice on a Sunday, while the Post Master General, his Deputies and Clerks, doing duty at St. John, are relieved from Sunday labour altogether. We entirely agree with our contemporary, that the labour performed by the Post Masters in the Province during the week is quite enough for the pay they receive, and we do not believe that any necessity exists for openng Post Offices on a Sunday, or for running a Mail on that day between any of the towns in New Brunswick, nor do we believe that the people look for, or require such services. If the Surveyor is very anxious to run an extra, let him take off the Sunday night Mail, from Fredericton to St. John, and run it some week day between Fredericton and Woodstock. Our Mails sent to the lower part of the Province are all jumbled up in a heap. One leaves here on Tuesday morning, one on Wednesday morning, and one on Friday morning, and from Friday morning until Tuesday morning again, there are none sent. If some alteration is not made in this arrangement. Street's express will have more to do this winter than the regular Mail.


