LEGISLATIVE SUMMARY.

By Telegraph to the Sentinel News Room.

FREDERICTON, Monday, April 5, 1852. House in Supply this morning and passed some very important grants; one of £537 to the Queen's Printer for reporting Debates, and one of £1100 for public buildings. The Supply Book is closed. An application from N. B. Secretary for the use of the Province Buildings next October for the Provincial Exhibition was carried 15 to 12. Tuesday, March 6 .- A Bill was passed suspending the St. John saw-dust law six months. A Bill was committed that the first applicant for a Timber Berth should get it without public auction, which was postponed to next Session. A Bill amending the Agricultural Society Act, was passed. Mr. English moved a clause that no officer of an Agricultural Society do receive a salary; this was lost. A resolution was passed for an address to the Governor, expressing the opinion of the House that the Governor's salary should not exceed £1500 a year The Westmorland Scrutiny Committee vacating Chapman's seat, and a new election has been ordered. A Bill was committed to reduce the tees in the Clerk of the Pleas office. A large number of Bills were postponed. The Prorogation takes place to-morrow at two o'clock.

Wednesday, March 7.—This day His Excellency, the Lieut. Governor, came in the usual state to the Council Chamber, and being seated on the Throne, commanded the attendance of the House of Assembly, who being come, His Excellency was pleased to close the Session with the following Speech:

"I congratulate you on having brought to a close a Session of considerable length and considerable importance—a Session marked by the enactment of some measures which may in all probability exercise great influence on the future destinies of this Province, and of British North America generally.

" I conceive it to be of great moment that, as the interests of Pritish North America are in reality one and the same, so the Legislative action of the several Provinces should, as far as possible, correspond. I think therefore, that besides the Railway, another step has been taken in the right direction, by the passing of the Act for regulating the currency of New Brunswick, and I trust that Canada and Nova Scotia may pursue a similar course.

"The School Bill which you have passed after full deliberation and discussion contains an element of success hitherto wanting in previous measures of the same kind,-I mean the provision for inspection and superintendance. I anticipate much benefit from this change.

"The Bill authorizing a Commission to be appointed for reporting on the amendment and consolidation of the Law, offers the best means for securing due care and deliberation in so important a matter.
