ANDREWS & QUEBEC RAILROAD .- The ship Speed, with a number of men to be employed on the Railroad, with their families arrived at St. John last week, and were landed here from the steamer Nequassett on Thursday last; they are fine, hearty, robust fellows. Several Engineers and other gentlemen to form the Staff of an efficient Railway corps also came out in the same vessel. On Friday last, the large party partook of an excellent Dinner, at Phaesant's Hotel, given them by their spirited and generous employer, G. W. King, Esq., one of the contractors, upon whom the direction of the line devolves, to whose business energy and tact the rapid progress which has been made with the work within the last fortnight, may be attributed. Some time must elapse, however, before the necessary preliminary arrangements can be completed, "to put on the steam"-and place large crews of men along the line, but from present appearances a few days will be sufficient to make all things ready. The iron rails are now placed near the track for the purpose of being laid down immediately: the Locomotive, the "Pioneer," as it has been aptly named, has been cleaned and made ready for action at any moment, and the time is fast drawing near-that great crisis in the annals of New Brunswick, when the first engine will commence running on the St. Andrews & Quebec Railroad; a happy consummation truly, to the hopes and fears of its projectors and ardent

THE STOCKPORT RIOT .- This riot appears to have been one of the most fearful character .-Its origin is stated as follows :-

The Roman Catholic schools announced their intention of walking on Sunday, and the Protestants directly reminded them of the Proclamation, and in such terms as to indicate the worst of feelings. The procession took place however, and was peaceably conducted, a body of Irishmen, four abreast, marching in front as an advance, and others accompanying it as a safe guard. It is said that many of those who formed the guard were strangers. There were in the procession a few crosses, but little display of any other kind-no canonicals, no guild dresses. Sunday night passed off with quietness, but on Monday the breach of the Proclamation formed the subject of much conversation in the town, and at night a party of Irishmen and Englishmen meeting at a public house, and getting from words to blows, the Irish ran into John street and Edward street, and got a reinforcement from their countrymen. The English also sought support, and in the end the Roman Catholics were beaten, and many ill treated. The result of the fight was one man killed and sixty wounded. Several houses were torn down, and the Catholic chapel sacked; the organ, altar, and furniture burned in a bonfire, The following persons were initiated and in- and nothing left but the bare walls. The military was called out, and succeeded in quelling the riot. The recent Proclamation of the Queen was the cause of the disturbance.
