A short debate arose on a resolution moved by the Honble Mr. Smith, that there be granted to the Magistrates of the County of Westmorland, the sum of - to enable them to erect a new jail. The resolution was ably sustained by His Honor the Speaker, Hon. Mr Smith, Honorable Attorney and Solicitor Generals, Messrs. Steadman, McPherson, McPhelim, End, and others .-And opposed by Hon. Provincial Secretary, Messrs. McLeod, English, and others. On the question being taken the resolution was sustained 18 to 14, and the blank filled up with £400, not to be drawn until an equal amount is assessed for and collected in the County. The chairman shortly after reported the resolutions. When the Election till received its third and last reading, and passed the House yeas 26, nays 10. The same members noting against it as before.
