The following Bye-Laws, passed by "the Municipal Council of this County, have received the sanction of His Excellency the Lieutenant Governor, in Conncil.

BYE-LAW TO PROVIDE FOR THE PREVENTION AND REMOVAL OF NUISANCES INJURIOUS TO HEALTH, AND FOR THE PROMOTION OF CLEAN-.LINESS, IN EVERY PARISH, TOWN AND VIL-LAGE, IN THE COUNTY OF CARLETON.

Be it ordained by the Municipal Council of the County of Carleton, as follows-

I. Any person who shall, upon request of any inhabitant, neglect or refuse to remove from his or her yard, house, barn, cellar, privy, or any other part of his or her premises, or in his or her occupation, any filth, dirt excrement, nuisance, or any other thing injurious to the public health, or whereby, or by means of which the public health for each and every offence, be liable to a penalty may in any way be endangered, shall be liable to not exceeding five pounds nor less than ten shila penalty not exceeding five pounds, nor less than lings. five shillings for each and every offence.

V. Every person or persons owning or occupying any dwelling house or other building or buildings, shall at least once a month during the months of June, July, August, September and October, in each year, clean or cause the same to be cleansed, so as to keep said dwelling house or other buildings in a clean and healthy condition. VI. Any person or persons who shall slaughter any cattle, sheep, swine or other animals within 1y the following district in the Parish of Woodstock, viz :- commencing at Lane's Creek (so called) thence running southerly along the river St. John to Upham's Creek (so called) and extending westerly or back one mile, during the months of June, July, August and September, in each and every year, shall be liable to a penalty not exceeding five pounds nor less than ten shillings for each and every offence.

A Bye-Law to provide for the more effectual preservation of Good Order and the Public Peace in every Parish, Town and Village in the County of Carleton

Be it ordained by the Municipal Council of the County of Carleton-as follows,-

1. No person shall fire or discharge any gun, pistol, or other species of fire-arms (except in the discharge of some military duty or exercise re quired by law) in or on any public street, square, thoroughfare, alley, road or bye-road, or within five hundred feet of any such street, square, thoroughwhere the person resides, or may be found, upon Bangor. fare, alley, road or bye-road, under a penalty not the certificate of a physician that there is a necesexceeding two pounds nor less than five shillings sity for the same, shall have power to remove to a for each and every offence. hospital, or other place designated or appointed by II. A Bye-Law to prevent the Encumbrance of Streets, Highways, S.c., in every Parish, Town and Village in the County of Carleton. Be it ordained by the Municipal Council of the County of Carleton,

I. Any person who shall place or cause to be placed upon any of the streets, highways, alleys," thoroughfares, roads, bye-roads, squares, sidewalks, or pavements, any wood, boards, bexes, bales, barrels, hogsheads, pipes, puncheons, bags, carriages, sleds, wheelbarrows, waggons, carts, dirt, ashes, manure, hay, straw, rubbish, or any obstruction or incumbrance of any nature or kind whatever, shall be liable for each and every offence, to a penalty not exceeding five pounds uor less than five shillings.

Be it ordained by the Municipal Council of the County of Carleton as follows,

I. The said Municipal Council, for the time being, shall be a Board of Health for the said Coun-

II. There shall be appointed for the Parish of Woodstock, twelve Sanitary Commissioners, and for each of the other Parishes of the said County, seven such Commissioners, whose duty it shall be to enforce the Bye-Laws of the Municipality relating to the Public Health, and such Rules and Regulations as may be made from time to time, by the said Council, for the preservation of the Public Health, and for the removal of all nuisances injurious thereto.

III. The Members of the Board of Health, or any of them, or any Sanitary Commissioner, shall have power and authority to enter into any house building, yard, enclosure, or other place within the said County, and to remove or cause to be removed therefrom any noxious, unhealthy or offensive matter, and to cleanse, ventilate and fumigate, or cause to be cleansed, ventilated and fumigated, and to use any other means for purifying the same.

IV. Any member of the Board of Health, with three of the Sanitary Commissioners of the Parish


