As Rev. Mr. Hyde, missionary, was leaving Naplous, a half witted Arab, who was considered holy, demanded alms, and on being refused, seized his gun, which unfortunately exploded, and killed the man.

The Arab population immediately rose and plunlered the house of the English Consul. The English school and a Greek Church were

torn down, and the disturbance ended by killing the father of the Russian Consul, who was trying to defend the property of the English. Mr. Hyde took refuge in the Governor's house, and was brought to Jerusalem by an escort of eavalry, sent for him by the Pacha.


