We are anxious to see some improvements upon the law: its liberal policy will naturally lead to more liberal provisions. We think—and in this opinion, we happen to know, a great many of the inhabitants of this County agree—that there is more machinery about the law than is necessary or beneficial; that it might be simplified, and that, at the same time, the franchise right might be extended to a still greater number of the people.

Why not assimilate this to the Act for electing Municipal Councillors?—why not let the Rate-List be the Register?—and thus render the law more simple, convenient, cheap and effective.

ARRIVAL OF THE “ASIA.”

NEW YORK, Jan. 24, 1857.

Asia left Liverpool on 10th, and arrived at noon of to-day.

English money market easier. Consols 93½ to 94. Cotton active, advanced one-eighth of a penny per pound.

BREADSTUFFS.—Moderate business and but little change in prices. Canadian Flour quoted 33s. to 35s.; Western Canal, 31s. 6d. to 32s.; Indian Corn, 33s. 6d. to 34s.; Wheat, 8s. 6d. to 9s.—Provisions rather firmer.

A movement against the Income Tax has spread to Ireland, where it is rigorously discussed.

The Prussian and Swiss difficulty said to be virtually settled by interposition of France.

Paris conference closed on the 6th, having signed protocol, which, it is believed, will settle all the points in dispute.

ARRIVAL OF THE ARABIA.

HALIFAX, January 28.

Arabia left Liverpool at 1 o’clock, P.M., on Saturday 17, and arrived at 11.45, P.M., to-day.

Arabia encountered heavy weather.

Passed following ships: 17th, passed ship Constitution, of Bath, and brig Athens, of Newburyport, bound in; 18th, passed steamship Europa; 24th, exchanged signals with American ship Emerald Isle, steering west.

SWITZERLAND.—The Neuchatel dispute is virtu-

ally at an end. On Tuesday, 13th, the Committees of both Houses of Swiss Federal government, adopted the proposition to release the prisoners.

A telegraph despatch from Berne, further announces that the National Council have adopted the propositions of Federal Government, with considerations of the commission, by 91 voters, against 4; one member abstained from voting. The Council of States has not yet voted. On part of Prussia, no formal engagement has been made, but it is understood that King of Prussia renounces all claim to sovereignty or revenue of Neuchatel.—The castles of Neuchatel and Lechtel will, however, remain the King’s private property, and display the Prussian flag, and the revenue derived from their domains is to be disbursed in local charities. Revenue is about \$15,000 a year.

BRITAIN.—West India Mail Steamer “Time,” ashore at St. Albans, already reported, still remains aground, water entering with every tide; passengers landed, and part of cargo being removed. It will take ten days to float her off, if very favourable; not insured. On the 9th, steamship lost of that line. John Carswell, Henry Cottings, and John Lewis, second and third mate and boat-swain of ship Guy Mannering, are committed for manslaughter at Liverpool, in connection with the death of a man, name unknown except George, supposed to have been a grocer’s clerk, who was shipped at New York as a seaman. Meetings continue to be held throughout the country against continuation of War Tax on Income.

FRANCE.—Fouik Kalm, the Persian ambassador, has arrived at Marseilles with suite of 100 persons. Opening of Legislature is appointed for Feb. 14th. Bishop of Amiens is appointed Archbishop of Paris.

SPAIN.—Madrid dates to the 19th, news unimportant.

TURKEY.—Porte has approved the financial negotiations respecting a new Bank, which will therefore commence operations at once at Constantinople. The capital, 8,000,000 piastres. Is rumoured that Mr. Kayard has obtained concession for Railway from Rutchuk to Gulf of Saros, which French and English Governments favour, with a view to military purposes. General Chesney has obtained the concession for the Euphrates Valley for road. A commission of Generals is appointed to prepare a plan for reform of Turkish army.—Letters, Jan. 5th, say the diplomatic conferences relative to Danubian Principalities continue; the third had already been held at Lord Stratford’s house. The point on which discussion has principally turned, has reference to political classification of Boyards, or noble proprietors of land. It was the proposition of Porte to establish two classes of Boyards—Great Boyards and Small Boyards; but the Ambassadors objected to this division, and resolved that one uniform class of proprietors is to exist. The division would have been a great weapon in the hands of Government.

RUSSIA.—Brussels Nord publishes despatch from Russian Government to Russian Envoy at Vienna, dated Dec. 30th, respecting Neuchatel affairs.—Despatch says: The Imperial Cabinet cannot but admit that His Majesty the King of Prussia has remained within the strict limits of his right; it therefore does not think that the slightest restraint should be put upon the freedom of action of His Majesty, as to what may be the measures he may think fit to employ to obtain the satisfaction he asks for.

CHINA.—The China Mail, of Hong Kong, which contains intelligence from Canton, four days later than that brought by last mail, says: “The principal incident during week has been the proceedings of the United States squadron, consequent on the unjustifiable attack made upon a party of Naval Officers and civilians, by bravos occupying barrier forts, and which is likely to involve the Americans, much against their will, in a quarrel with the Chinese.

BERNE, Friday.—Final vote of Federal Assembly of Switzerland has just been taken upon propositions of Federal Council for settlement of dispute with Prussia. The Council of State, which, together with Cantonal Council, constitutes Federal Assembly of Switzerland, having separately discussed the propositions in long and animated debates, have just resolved upon their adoption. There were 82 members voting in majority. Minority was composed of Messrs. Fasey, Vogt, and Pignat. PARIS, 16th. Royalist prisoners are to be set at liberty and conducted to French frontier at Vegniers, under escort of Swiss troops. French passports will be delivered to them.

TRIESTE, Friday.—We have news from Constantinople to 9th. Ibrahim Pacha has beaten Russians in Circassia; Russian General was killed in action. The English Government wish to disembark force at Bassorah, on Tigris River, where river forms dividing line of Turkey and Persia.

MILAN, Friday.—Emperor and Empress of Austria, accompanied by Count Buol, and Barons Back and Bruck, have to-day made their entry into this city.

Telegraph despatch from Madrid states that 25 political prisoners have just contrived to escape from Valencia.

From Times’ City article, Chinese advices bringing full details of operations at Canton to 24th Nov., and of continued obstinacy of Governor Teh, who, notwithstanding the destruction of the Bogue forts by English, and Barrier forts by Americans had issued a proclamation, threatening marshal law to any of the people who might venture to speak of peace, has caused increase of firmness in London Tea Market.

The Annual Report of the Rev. Dr. Ryerson, Chief Superintendent of Education in Upper Canada, for 1856, has been laid upon our table by a friend. It seems to us that we cannot better subserve the cause of education in this Province than by letting our Legislature and people know what advancement it is making in Canada, and the course there recommended. We shall therefore borrow largely from this masterly report before us—giving, without remark, such portions as seem most applicable to our people.

BRANCH RAILWAY.—The following important paragraph appeared in the *Calais Advertiser* of the 15th instant:—

“We understand that the Commissioners appointed by the New Brunswick Legislature to locate a route and terminus for a branch tract from the St. Andrews and Quebec railroad to the St. Croix River, have decided upon the Ledge as being the best place for the terminus, on account of its excellent harbor. It is accessible at all seasons of the year, and at all times of tide by ships of 2000 tons burthen or larger. It would accommodate the mammoth steamer as well and as securely as Portland harbor, about which is so much talk. Land which could have been bought a few months ago for from \$200 to \$400, cannot now be bought for so many thousands.”

We learn from the *Church Witness* that Charles Simonds, S. Wiggins, H. Gilbert, J. Gillis, Esqrs., and 45 others, presented the Rev. I. W. D. Gray with an address and a cheque for £100, as a token of their respect and esteem for the able manner in which he conducted that paper while in connection with the editorial department.

The *Observer* has resumed its folio shape and former appearance.
