The Committee of the Board of Supervisors, appointed to examine
and report upon the accounts of the Aims House Commissioners for
the year ending Nov. 30th, 1872, have attended to that duty, and
submit the following Report—
They find the Commissioners' balance on hand on the 30th
Nov. 1871, nine hundred and eighty-three cents
(\$908.34) as per audit of account at that date; that they have since
received the sum of eleven hundred and fifty-three dollars and
one cent (\$1153.01), to this may be added fifty-three dollars, due by
the Keeper of the Aims House on Stock; making in all the sum of two
thousand one hundred and fourteen dollars and ninety-three cents
(\$2144.94).

They find the expenditures for the year to be nine hundred and
forty-three dollars and eighty-seven cents (\$943.87); showing balance
in Commissioners' hands, on the 30th Nov. 1872, to be eleven hun-
dred and seven dollars and seven cents (\$1171.07).
Your Committee, by opinion that the expenditures of the Board
a sufficient sum to the Commissioners to retain in their hands at any
time, and that they should be required to deposit in the Savings
Bank any surplus in their hands over that amount. Said funds so
deposited to be drawn on the order of the Chairman of the Board of
Supervisors, with the approval of any three members of the Board.

The Committee find some of the vouchers unsatisfactory, they be-
ing merely a certificate from the Commissioners that the articles
mentioned were delivered to the paupers, but there appears
no vouchers from the paupers who received the goods. While the
Committee have no doubt that in the cases referred to the goods
charged were actually delivered to the paupers, they cannot ap-
prove of the present mode of the rate-payers, and will enforce
the voucher of the parish receiving support should be obtained.

The Committee believe the general management of the Commis-
sioners has been such as to merit the approval of the Board.
The Commissioners, together with the rate-payers, have an assess-
ment of one thousand dollars to meet the expenses of the year
present year. And as your Committee are of the opinion that pro-
visions should be made to meet any emergency that might arise dis-
posed to be drawn on the order of the Chairman of the Board of
Supervisors, with the approval of any three members of the Board,
for the present year.

Your Committee would recommend that the account of the Com-
missioners, together with this report, be published in the *Freeman*
and *Sentinel*, for the general information of the rate-payers.
Before closing this report the Committee would state that in their
opinion the Aims House and farm is not a paying institution for the
rate-payers; they would therefore recommend that action be taken
with a view to its disposal.

NO SABBATH.
In a prize-essay on the Sabbath, written
by a journeyman printer in Scotland,
which for its vigor of language and
beauty of expression, has never been sur-
passed, there occurs the following passage.
Read it, and then reflect for a while what
a dreary and desolate page would this
be if the Sabbath were blotted out
from our civilization:
"Yokel! I think how the abstraction
of the Sabbath would hopelessly en-
slave the working classes, with whom we
are identified. Think of labor thus
lost in one monotonous and eternal cy-
cle, the dreary monotony of the day
forever straining, the brow forever aching,
the feet forever plodding, the brain
forever throbbing, the shoulders forever
drooping, the loins forever aching, the
restless mind forever scheming.
Think of the beauty it would deface,
the merry heartedness it would deface,
the bright smile it would deface, the
resources of nature it would crush,
of the sickness it would breed, of the
projects it would wreck, of the groans it
would extort, of the lives it would imma-
late, and of the cheerless glare it would
permanently dig! See them toiling and
sweating and striving, and getting rich
and having, weaving and spinning, dig-
ging and gathering, mowing and reaping,
raising and building, digging and plan-
ting, striving and struggling—in the gar-
den and in the field, in the grunary and
in the barn, in the factory and in the
mill, in the street and in the shop, on
the mountain and in the ditch, on the
road-side and in the wood in the city
and in the country, out at sea and on the
shore, in the days of brightness and of
gloom. What a picture would the world
present if we had no Sabbath!"
