Take for instance the chapter on Louisbourg; I think Mr. Harper takes about the same space as our present history, and I fail to see any improvement in his recital of the events. Hence I think the term "voluntaries" need not be hurled at Archer any more than at Harper's History.

Surely the records of our country are sufficiently discordant without perpetuating old or introducing new causes of discord. We should not consider the inhabitants of Ontario or of any of the western provinces as a distinct people from those of the provinces by the sea. Why then not consider the history of one as important as that of another? or rather why had we not better, as far as our schools are concerned at least, consider the history of Canada as that of our country rather than take up only a section of it as such.
