


County of Carleton, humbly sheweth that the present connection of Town and Parish is a loss to both sections, and more especially

That this connection was the work of the people of the Town in their Act of Incorporation which, framed in their own interest, was so drafted as to place the people of the Parish at a disadvantage, and they not having been consulted, and having no voice in forming the connection, ought not to be lon-

That the Parish, which is nearly equal in population and wealth to the Town, ought not to have its business done by the Board of Supervision, which is so constituted as to place its people in a position of cisa ivantage and inequality; said Board being composed of the Mayor and six Councillors on behalf of the Town, while the Parish is represented by the two County Councillors, who in part also represent the Town, being elected by Town and Parish jointly. The Parish is thus without any independent representation at the Board by which its business is trans-
