

Section 1-Authorizes the Town Council to construct such ystem os water works as it may deem advisable, for protection against fire and sanitary, domestic and other purposes ; with power to appoint the necessary officers ; define their duties, and provide for their remuner-

Section 2-Authorizes the entering upon any land within or without the limits of the Town, for the purpose of making surveys, observations, plans, &c., for obtaining infor-formation as to the best systems of works or the location thereof.
