Verdict for plaintiff for \$50, the Judge rejecting the different points of law raised in the case for the consideration of the Court above. D. McLeod Viner & S. Jenkins, counsel for plaintiff; A. B. Connell, counsel for defendant.

The prisoners were brought into Court to receive sentence on the indictments against them. Stephen C. Somers was sentenced to five years imprisonment in the Penitentiary, and James Clout to two years, both with hard labor.

The records in the following cases: Craig vs. Currie and Baird vs. Scholey were withdrawn, and the Judge ordered the case of George Atherton vs. the Town of Woodstock to be made a remand.

Court then adjourned sine die.

The harvest of Ontario has proved to be an exceptionally good one, even better than was anticipated early in the season. In quality of the grain and in the yield per acre the above statement holds good. Of wheat, barley, oats, rye, the aggregate yield is 145,954,274 bushels, against 97,383,290 bushels in 1883. Of corn the yield is 84,804,937 bushels in 84 against 56,517,117 bushels in '83. The information upon which these figures are based is compiled by the Bureau of Industries.

Reading these figures which may be relied upon as being very nearly correct we are led to regret that it is impossible to raise the amount at present available, or at all events to have a reliable aggregate of the productions of the farms of New Brunswick can be reached. Assuming, without knowing what it costs, that we cannot afford a Bureau such as that in existence in Ontario, it appears to us that in some way the local agricultural societies might be made of practical benefit if they were charged with the duty of collecting, annually, agricultural and other industrial statistics, from which, without having to wait for the census, the people at large might be informed in these matters which are of very great interest and importance.

While provision is being made for the amusement and physical advantage of our young people, it may be hoped that some attention will be paid to the intellectual matter, contributing to the intellectual wants of the community. The cultivated mind and cultivated body united form the perfect man. And it is a shame to have the means for either neglected. Some of the churches have done their duty in this sphere in the past, and the Old Fellows, at a sacrifice of time and money, have also done what they could to inspire a taste for intellectual attainments, and to afford food for the gratification of that taste. We hope, notwithstanding the disappointing experience of the past, provision will be made for public lectures during the winter. The season for such is at hand. In other communities it has already been done, and we, without the first of our bodies, religious or benevolent, to inaugurate a course of popular entertainments? The tendency of the times is not, we fear, in the direction of intellectual elevation. If our fears are correct the fact is to be deplored and should challenge the thoughtful consideration of all who, rightly estimating the existing state of mind, culture and mental development depends what is trust and belief and solid as regards the happiness and progress of society.

While we are not believers in the old world system of honorary titles as desirable in this country we can readily endorse the view expressed by the *Sun*, regarding the recent distinction conferred upon Sir John A. Macdonald, as an honor conferred upon Canada, when it says: "So long as these honorable distinctions are used to reward distinguished merit in military, political, scientific and philanthropic circles, we are glad that such honors should be bestowed upon those worthy to wear them, and that the standard of the throne as to be considered among the first in their bestowal."

We may add that the order of the Bath is the second order in rank in England, the first being the Garter. Sir John has been promoted from the second class, composed of Knights Commanders, to the first class, Knights Grand Cross.
