Warden in chair—Councillors all present.  
 Minutes of last meeting read and approved.  
 Mr. Gibson proposed against decision of  
 yesterday about division of road money.  
 He moved that Northampton was unjustly  
 treated by the present division of the money.  
 Mr. Gibson moved, seconded by Mr. Brad-  
 don, to reconsider the by road money resolu-  
 tion of yesterday.

On motion of Mr. Bradton, seconded by  
 Mr. Cronkite, the following were appointed

Mr. Bradton moved the issue of piece of  
 property land to Mr. Jones as agreed upon last

 Scott Act Inspector.  
 Mr. McClinton said he had read in a com-  
 munication in the Press yesterday that he  
 was growing rich out of the Scott Act, but  
 he was not rich in the report. He had  
 never made one cent out of any kind. All  
 he did was to get the money for the county  
 and he had to pay out money for witness and  
 constable fees and without it till his bills  
 were paid by the county.

The bill, \$344.25, which he laid before the  
 council yesterday was for money paid out by  
 him for costs in conducting cases under the  
 Act.  
 In answer to questions by councillors he  
 said:

He thought there were 72 convictions on  
 which the fines were not yet collected.  
 There were 30 convictions sustained in  
 1892; seven of them were first offences.  
 He thought four cases had failed of conviction.  
 There were 19 or 20 convictions appealed.  
 The defendant had taken copies of all,  
 but all had been confirmed except the second  
 and third offences. There were no orders for  
 stay of proceedings in 18 cases.  
 Five convictions had been made through  
 information by residents of the county.  
 He did not say to Edward Stevenson's  
 wife that he would not serve the summons if  
 he could avoid it; he could have avoided it  
 if he had wished to do so.

He never had received any information  
 with a bona fide man to it that he did not  
 pay attention to.  
 He did not see Oakburn, of Florenceville,  
 since last meeting of council.  
 He had not received any information  
 against persons at Boundary Line on the  
 Houlton road.  
 He had visited Aberdeen in 1892, looking  
 for what he could get.

The cost in cases is usually about \$7,  
 sometimes a good deal more.  
 He employed the detective after talking  
 with the Scott Act committee about it.  
 The county pays the expense.  
 There is no law standing against Ann Ball  
 in Aberdeen; he had never taken part of a  
 fines from him.  
 James Gray had been released by a judge's  
 order, and by the judge's ruling he could not  
 be confined again on the convictions against him.  
 He had had convictions against some per-  
 sons but in one year.

He thought he had succeeded in stamping  
 out the traffic in liquor of the county.  
 Mr. Gibson asked if the Scott Act was  
 in 1892 then in 1891, how was it sold  
 than under the license system.  
 He got no assistance from members of the  
 council, except the committee.  
 A few temperance men render him as  
 assistance.

The cases proved under the detective only  
 about \$7 each.  
 There are responsible gentlemen who visit  
 room shops and drink, but when wanted for  
 witness they cannot be found.  
 He had had some 20 cases before the  
 information of the Detective, and only four  
 convictions were made out of the whole.  
 On motion of Mr. Saunders, sec. by Mr.  
 Hartley, the Inspector's report was adopted.  
 On motion of Mr. Saunders, sec. by Mr.  
 Munro, G. McClinton's bill for \$344.25  
 was ordered paid.

Some of the members not being satisfied  
 with the decision of Mr. McClinton's bill,  
 on motion of Mr. Harding, sec. by Mr. Flem-  
 ming, it was reconsidered.  
 Mr. Moore asked if the Board was obliged  
 to pay the \$220.00 bill for expense of  
 Detective Robbins.  
 Mr. Saunders reminded Mr. Moore that  
 he had just said to Inspector McClinton that  
 he had the whole county bank of him. If  
 the council would not pay the expenses they  
 could not expect the work to be done.  
 Mr. Gibson objected to giving such a lim-  
 it to the Inspector. He did not believe it  
 necessary to send to Boston to employ a de-  
 tective, while there are just as capable men  
 here as there.

Mr. Harding said the Scott Act had been  
 adopted by this county almost unanimously  
 but it could not be enforced unless the Board  
 would back up the Inspector. He would  
 grant Mr. Cartwright just as good men would  
 be found in this county as anywhere; but they  
 could not get men here who would do the  
 work of London or New York. The Scott Act
