

O'Brien ridiculed Dr. Mont-ague's argument that the masses of the peo-ple were not interested in British goods, ex-cept as luxuries, by showing that we import-ed \$18,000,000 worth of goods last year from Great Britain on which duties were paid. He taunted Dr. Montague with being too ready to follow his leader into many a ditch. The Government had no intention of inter-fering with the national Policy, because the speech of Dr. Montague included a defence of one of the worst combines in the country. As one who had supported the National Policy since 1870 he now denounced it as having given rise to many evils. He would sive the farmers relief by decreasing their purchasing power. He condemned a pro-tective system. He did not think the coun-try was prosperous and the figures of the census intended to bolster up such a belief were simply rubbish. These figures made nim lose confidence in the infallibility of the Minister of Finance. Dealing with Mr. Fos-ter's speech he said that the Government avidently thought itself a little providence. One would think they were gods sitting on Olympus, instead of twelve ordinary mor-tals, very ordinary. (Laughter.) The peo-ple of Canada had got to far imbued with the spirit of unrest that they looked for-ward to annexation as a possible relief if they did not not get it in any other way. (Hear, hear.) He was not enamored with reciprocity, although it would be folly to ignore such a great market as the United States. 
