The cheese factory at Glassville has been in operation ten years and the business is gaining. Last year's output was twenty tons and this year they expect to reach twenty five tons. They open the factory on the 1st June; they have now four tons made, which shows plainly there are some good farmers at Glassville, who are willing and know how to work.

The question was asked the writer if he was a thoroughbred Yankee. In reply I asked the question, what is the difference between a thoroughbred Yankee and a grade, and I also answered that when a grade gets over the line he swells very big when potatoes bring \$3.00 a barrel, but a thoroughbred Yankee grade or no grade, when he's across the line, expects to succeed by hard work.

From Windsor to Glassville is some six miles. There is a sawmill doing a good business, which is very convenient for the people. Thomas Forrest is superintendent of the Sabbath School. A blacksmith shop is doing a good business. There are three mails a week.

Glassville was settled by emigrants some 50 years ago; then some of the other citizens of Carleton county followed. Mr Miller was one of the first settlers. It is now a flourishing, industrious and prosperous farming country; four roads meet. A hotel is doing a good trade. A post office handles a very large mail. Four stores, a meat shop, two blacksmith shops and a millinery shop are doing a good business.

A few years ago he sold his farm at Lower Canterbury and he and his wife went to live with their youngest daughter in Woodstock, who tenderly cared for them in their old age. The deceased went down to visit the old home, took sick and in a few days died. The funeral was a large one and was attended by Revs J J Barnes and J Noble.
