## More Pay for the Militia.

We understand that a great deal of satisfaction is felt by the soldiers on account of the increased pay which they will receive in future. On account of the generous treatment at the hands of the militia department, the head of which is Sir Frederick Borden, a superior class of men will be easily obtained, and the incentive to drill the full three years will be greater on account of the increased pay each year. ## The Cabinet Vacancies.

Premier Tweedie does not seem in any hurry to fill the vacant portfolios in his administration. No doubt the abundance of suitable cabinet timber at his disposal renders the choice somewhat difficult. There are plenty of men on the government side with strong claims to advancement, but we know of none so well adapted for preferment as the member for this county, Mr. W. P. Jones. As a practicing barrister he bears an excellent reputation, on the platform he can easily hold his own with all comers, and we are quite of the opinion that he is not without a considerable amount of that personal magnetism which is so essential to a successful political career. It is certain that the claims of Carleton County to a seat in the executive are receiving the serious consideration of the government.

## A CONFIRMATION TOUR.

His Lordship Bishop Casey administered the sacrament of confirmation to 170 children on his visit to the county this week. On Sunday, 42 were confirmed in St Gertrude's church, Woodstock. His Lordship, accompanied by Rev Fr McMurray, went to Newburg on Monday morning, where there was a class of 11, and in the afternoon at Clearview 14 presented themselves for confirmation; on Tuesday at Johnville there were 95. Mr D McGaffigan had a carriage in readiness and drove His Lordship and Fr McMurray to Florenceville where they were the guests at the home of Mr and Mrs D McGaffigan until their departure for Williamstown where on Wednesday 8 received the sacrament. Wednesday evening His Lordship was the guest of Fr Murray, and on Thursday he left Woodstock on his way to St John.

## VICTORIA CO. COUNCIL.

The July session of the Victoria county council met at the Court House, Andover, on Tuesday morning and concluded the business on Wednesday, the following councillors being present, Warden Howlett in the chair:—

Andover—James W Howlett, Geo E Baxter.

Drummond—Anders J Jensen, D Mulherin.

Grand Falls—Chas Mulherin, Jos LeClare.

Gordon—John Ryan, E T Campbell. Lorne—John Barker, Jas Jenkins. Perth—O R Inman, Peter Anderson. Coun Anderson, a new member from Perth, addressed the board. Coun Anderson takes the place of Mr Brymer, resigned.

The morning was devoted to a discussion of the repairs on the Court House, which will cost \$2000, and the building committee was given full power to arrange for the heating of the building.

The afternoon session was devoted to a discussion on ferries in general and the Johnston ferry in particular, which is now being conducted by Ward Baker, who had failed to take out a license, which had been offered to him for \$85, he being the highest tenderer. The matter was referred to the ferry committee of Grand Falls and Drummond, who will consult J F Tweeddale, M. P. P. for the county.

The council in committee of the whole passed all the bills which amounted to less than \$300. Subsequently a bill of Alex Stratton's in connection with the Curry lawsuit, which amounted to \$104.60 was ordered paid when certified to by the clerk of courts. A committee was appointed to ask the local government for a refund in the Curry case, as the lawsuit was caused by the interference of one of the former local members, after the ferry had been sold by the council.

A resolution was passed asking the seven local members to unite and work to secure a representative in the Executive Council of the province for the upper counties.

A resolution was passed protesting against the infringement upon the rights of the municipal councils by the local government in taking over the highways, liquor licenses and appointing one of the revisors, thus

restricting the work of the councils. The resolution will be forwarded to all the county councils with the exception of St John, for consideration at the January sessions.

A communication was received from W W Hubbard advocating the holding of fairs in different parts of the county for the sale of stock. Referred to a committee.

Notice was given that at the January session a motion will be made that the July session be dispensed with on account of the limited amount of business now under the jurisdiction of county councils.
