To the Citizens of the Town of Woodstock.

I would state that in ruling Coun Leighton's resolution asking for tenders for Electric Power for pumping and electric lighting, out of order at the meeting August 6th, I did so as a protest against such a proposition as it contained, that is the Town investing any money in an experimental pumping and lighting equipment, in such a way that the Town will be at the mercy of any Power Company at the end of the contract, and in hope that such action on my part, might attract the attention of the ratepayers to the proposed action of the Council.

The report of Mr Barbour does not advise the use of Electric power for an auxiliary pumping plant, in connection with our present system, unless we can get 250 horse power, and such a course is not contemplated by Coun Leighton's resolution.

The scheme proposed by Coun Leighton's resolution and remarks is, to instal a pump and Electric Motor to work in connection with our present system, and is an experiment and while it may prove to be satisfactory for our requirements, yet it should be borne in mind that it is only an experiment, and that its introduction at this time is due to the completion of the New Dam Power Co and the desire on the part of that particular Co to secure a contract to pump the Town water as well as to Light the Streets. It is well to consider that the expert employed by the Town to advise in regarding the improving of our Water supply does not recommend such a course, in fact he states that Electric power is only justified in connection with a Storage reservoir which he points out will cost from \$20,000 to \$25,000 and only then in comparison with Steam power, if we can purchase the Electric power for about ONE CENT per kilowatt hour.

The Council is not in a position to go ahead and expend such a sum for a storage reservoir, as they do not at present have the authority even if they were so disposed, so that the use of Electric power will be in connection with our present Stand Pipe and is consequently only an experiment involving under such arrangements a large outlay on the part of the Town, for Pump, Motor and Lamps, and when such tender is accepted and contract made under such tender, if the service is not satisfactory it cannot be terminated, but the Town will have to pay to the end of such contract for just what they have to give, and on the expiry of such contract if such Power Co demands double the amount per year for a renewal the Town will have to pay the same, or throw aside the plant they have invested in.

There are only two Companies here who can tender for supplying the Power, and one Co can furnish Alternating Current while the other Co has Direct Current. Motors and Lamps to suit one current cannot be used by the other current, so that when the Town installs Motor and Lamps to suit the current of one Co they will have the monopoly when the time arrives to renew the contract. The present 24 Street Lamps will not be suitable for either Co unless a motor were installed in the Pumping Station to drive the Arc Dynamo there.

The Water & Light Committee submitted to the two Companies a form of proposal for furnishing Power, Motors and Lamps such form stating the price to be paid for current per kilowatt hour as well as by the flat rate, and separate prices as to Water and Light service, and under such tender the Town could at the end of three years pay the Co a stated price for Motors and Lamps and the Co in that event would renew the contract for a further term of seven years. Under such tender the Town could terminate the contract at any time if the service was not satisfactory. The Council also had the right to divide the contract that is, if one Co tendered lower on the water yet higher than the other Co on the Light, they reserved the right to accept the water tender, while rejecting the Light tender. They did not ask for a tender to combine both services, yet if one tender was lower both for light and water it would undoubtedly have been accepted. For some reason the New Dam Power Co object to disclose what they will furnish the separate services for as well as what they will charge per kilowatt hour, and insist on a tender on the lines as submitted by Coun Leighton I cannot see why the Town cannot purchase from the Power Co by the kilowatt, if they want to, in which case we can get the information suggested by our Engineer, so as to

arrive at an intelligent decision as to whether it will be cheaper to use Electric current or continue using steam, and the Town will have to pay for just what power they may require.

The Citizens should carefully study the report of the expert employed and what he advises in regard to improving our Water System and then see that the Council deal with the matter in such a way, that the interests of the Citizens are not sacrificed for those of any private Corporations. In conclusion I would say that it might be well to make the experiment providing the Town can get the power at such a rate that it will be as cheap as steam power, and that the outlay on the part of the Town be confined to purchasing and installing a Pump and connecting with the present system, the Power Co to furnish the Motor and Current for pumping and keep same in order, furnish and install the 40 Street Lamps and trim and operate same, and bind such Co to furnish satisfactory service, otherwise the Town to have the right to terminate the same, and in this way the experiment might be tried without incurring much expense, and under this arrangement the Town would not be at the mercy of any private company when the contract expired.
