The County Court.

There was a very large attendance at Court from all sections of the county this week. The chief interest centred of course in the case against B Frank Smith, who was accused of fraudulently receiving a quantity of saw logs without the consent of the owners.

His Honor Judge Carleton in his charge to the Grand Inquest of the County took occasion to comment quite severely upon the recent escape of one Sam Hudlin from the jail. There was an indictment before the Court charging Hudlin with assault and with escaping by breaking jail. This was the only criminal matter besides the Smith case.

After a short delay the jurors returned to their duties, and began hearing witnesses. David Alexander, sworn. At this stage the judge said Court would take adjournment until noon in order to give the Sheriff an opportunity to secure a new panel. His Honor said it would be well to give the Sheriff time to get men not present, as those who were mere spectators, although easy to get at, were apt to have some learning either way. The Sheriff was instructed by the Court to secure five talesmen.

Samuel H Havens Mr Carvell raised the point that Albert Bell, who was absent when the first panel was called, had since arrived, and was now present. He doubted if Bell could be passed over now that he was present. After some discussion between Judge and Counsel, it was decided to drop Bell and proceed with the new panel. Two had not arrived, consequently there was another lull in the proceedings. Upon resumption, called, with no objection, and sworn as the last juror. Upon the jury being called by name, the clerk read the usual charge, after which Mr Carvell briefly sketched the case for the Crown. He said the case was one instituted at the instance of the Log Driving Company, who for some time felt that some of their logs were being taken unlawfully by parties in the County. For the past few years there had been a big leakage. Two years ago they started to get Inspectors, this year appointing Albion R Foster. Mr Gregory, President of the Company, would under puty and he (Carvell) had in the suit. It would also be shown that no member of the Log Driving Co had given either Smith or Dyer permission to pick up their logs.

Mr Carvell went on to relate the circumstances in connection with

how the information came into the possession of the Inspector, and the possession of the Inspector, and the subsequent steps taken in connection therewith. He also related what took place when Foster secured the joint in question. In so far as he personally was concerned he, (Carvell) was simply acting for the lumbermen, the same as he would for any other client. Dyer's return was followed by information against Smith, after consultation with the Driving Company.
