## The County Council.

The Council held an interesting session this week, adjourning Wednesday night. The chief item of business was the resolution calling for the building of a new court house. To the great delight of nearly everybody this vexed question was amicably settled by the passage of the motion almost unanimously. The Council ordered the building committee to at once arrange for plans and specifications, to be laid before a special meeting of the Council in March. The idea is to have the new court house in town, on the county lot, alongside the record office.

The road law came in for some criticism, although there was little debate. There seemed to be nobody to approve of the measure at all, and the board by resolution condemned the \$2 poll tax, calling upon the government to reduce the amount to \$1.50.

A regular old-fashioned Scott Act debate was the feature of the closing day. Scott Act Inspector Colpitts was the target for a regular fusillade from many professed temperance councillors who argued in favor of appointing a younger man. A motion was actually carried, 18 to 6, calling upon him to resign, but the venerable official sternly refused to put his neck on the block. The advocates of a change then tried to put through a summary dismissal, but it failed, only Keenan, Lamont, King, Williams, Bull, Flemming, Gillmor, Rideout, Melville, Bell (Richmond) and Hay voting yes.

Another item which stirred up a little dust was the charge of \$2.50 per week made by the new sheriff for boarding each prisoner. The old rate was \$2.

Our readers will in our next issue receive the official report of all the matters which came up for discussion.

## Carleton County Election Case.

The Carleton County election case occupied the attention of Mr Justice McLeod in Chambers Wednesday morning. On application of W Harry Harrison for W J Owens, the petitioner in the action, his honor granted a summons calling upon the respondent, George W Upham, M P P, to show cause why a time should not be fixed for hearing, summons returnable Saturday at two o'clock in the afternoon. The petitioner is the successful local government candidate in the recent bye-election in Carleton County, the respondent, Mr George W Upham, M P P, being his successful opponent.

## "Grub Stake Himself."

The Toronto World makes haste to challenge the contention of its fellow Conservative, the Mail and Empire, that it is the duty of the State to pay a salary to the leader of the Opposition, and, by inference, it is the duty of the leader of the Opposition to accept it. The Mail, says the World, thus seeks to defend the mistake made in 1905, instead of endeavoring to have it corrected. The World reaffirms that Mr Borden "should grub-stake himself."

Mr W F Maclean's organ goes on to say that experience has shown that "this arrangement" (referring to the deal in 1905 whereby Mr Borden accepted from the Government a salary of \$7,000 in addition to the increased indemnity of \$2,500) "has led to a concision of affairs almost intolerable. It has enabled the Toronto Globe to assail Mr Borden with cruel jibes and brutal sarcasm, and it has created a condition which has been full of embarrassment for his political following and personal friends. The whole business is wrong in principle. Ministers of the Crown are paid, as officials, the same as policemen. They are higher officials, because they are called by the King in person or by his personal representative to assist His Majesty in the Government of the country; or, to speak more practically, they represent the political party which has been chosen by the nation to carry on the Government. The essence of an Opposition is to oppose. Nothing is more foreign to British institutions than the bi-partisan agreements which make a farce and a scandal of Canadian politics. Let the leader of the Opposition keep the Government at arm's length all the time."

"A leader of the Opposition should get along on his \$2,500 per annum if he has no means of his own to supplement it. He should lead the simple life. People now-a-days are disposed to ridicule the greatest jurist, and, possibly, the greatest man this continent ever produced, because, basket on arm, he did his own marketing every morning. The world's literature contains many a merry jibe at leaders who fought and struggled in ragged regiments to make men free. Let not the leader of an Opposition the articulate protest against abuses in high places, Dominion, Provincial or Municipal, be too solicitous about his income. If he has any mission any message for his countrymen he should be rather as a voice crying in the wilderness than as one clothed in fine linen and dwelling in the palaces of kings."

"Is this impracticable? It is less impracticable for this country to grub-stake nine Provincial Opposition leaders and one at Ottawa? How about the one lone Conservative in the Alberta Legislature? Would he get a salary for leading himself? We agree with the Mail that the leader of the Opposition should not be grub-staked by corporations or corporation promoters. It would be better to take up a collection, but openly, among his followers. Better still would it be for the leader to make a sacrifice, to lead the simple life—in short, to grub stake himself."

This is pretty plain talking which one would imagine Mr Borden would not dare to ignore, but, although Mr Borden is a man of wealth, we do not expect him to exhibit much enthusiasm for the "self grub-stake" proposal. In fact, he seems to like the idea of the Government doing the "grub-staking" for him.

## Mean and Spiteful.

For several weeks past the Toronto News, in caricature and editorial, has been pursuing Mr Charles Marcell, M P for Bonaventure, with a virulence worthy only of the small-souled partisan. The occasion for this attack on Mr Marcell, who is one of the most honorable men in public life, is that he is slated for the Speakership of the House of Commons. The News declares that Mr Marcell is unfitted for the office of Speaker because he based his appeal for re-election on the ground that he had procured the construction of a number of public works in the constituency.

The News has published portions of Mr Marcell's address to the electors, but, as the Toronto Globe points out, "the News has never made it clear that the address of which it complains was issued in the election of 1904, not in that of 1908. Since its issuance Mr Marcell sat for four sessions and was elected Deputy Speaker in the first of them. Not a word from the News, however, during all that time. There is no change in Mr Marcell, but there is in the News. It has changed in two ways: it has become the most pronounced Tory organ in the Dominion, and it has rather soured on the French-Canadian. Mr Marcell is of that race, and makes a good cock-shot for the amusement of the News' clients."

"But," adds the Globe, "even if it be admitted that Mr Marcell's address in 1904 is not outlawed, why does it unfit him for the Speakership? He is member for one of the outlying and neglected constituencies of the Dominion. It is inhabited mainly by humble fishermen, who gain a laborious, precarious, and dangerous living in the Gulf. The great national works which occupied the attention of public men prevented the wants of obscure citizens like those of Bonaventure from being much considered. Mr Marcell's constituents were greatly in need of wharves, lights, etc. National revenues were buoyant and Mr Marcell obtained as many appropriations for these purposes as he could. In doing so he did his duty. The essence of the individual representation of constituencies is that each section of the country will have at Ottawa a representative looking after its interests. Mr Marcell had a good case. His constituents had been absolutely neglected. Poor fishermen cannot build wharves for themselves. This is recognized in every civilized country under the sun, and it is a maxim of public policy that the central government should afford them facilities for pursuing their perilous calling. It will be said they are few in number. With increased facilities their numbers will increase. If the works were too costly or ill-advised it is the Government and not Mr Marcell who should be blamed. But, so far as can be ascertained they were useful works, which will greatly lessen the toil and risk along that inhospitable shore. The campaign against Mr Marcell is mean and spiteful in the last degree."
