McKEOWN AND BARRY TO SUPREME COURT BENCH.

F B Carvell Decided Not to Accept—Something About the New Judges—Both Appointments Popular.

The Hon H A McKeown of St John and Mr J T Barry of Fredericton have received their appointment to the Supreme Court of New Brunswick. It is generally conceded that these gentlemen will do honour to the high position they have been called upon to fill. Many people through this county felt that Mr F B Carvell, our own representative, would take one of these positions. It was well known that Mr Carvell would have had the position if he had chosen to take it. But he evidently preferred to remain the honourable and honoured representative of Carleton County.

Regarding the new judges the St John Telegraph has the following: It was announced here definitely on Saturday that Mr Carvell had decided not to accept one of the judgeships. Interviewed over the long distance telephone at Woodstock he said that he would not accept the judgeship and that Mr McKeown and Mr Barry would be the choice.

HON H A McKEOWN.

Hon H A McKeown is a native of St Stephen, a son of the late Rev Hezekiah McKeown. He is forty six years old, having been born in 1863. He received his education in the collegiate school at Fredericton and at Mount Allison, graduating B A in 1881. He entered the offices of the late Dr A A Stockton and Hon A S White where he studied law, being admitted an attorney of the supreme court in 1884 and the year following he received the degree of LL B from Toronto University.

He was first elected to the legislature for St John city in 1890. In the general election in 1892 he again offered and was defeated on the vote of the sheriff. In the general election of 1899 he was again elected for the city of St John and was successful in retaining the seat in the following election in 1903. Hon Mr McKeown was appointed a member of the executive council without portfolio and so continued till February of 1903 when he was made solicitor-general. After his appointment he was re-elected by acclamation but resigned to contest the seat in the federal house made vacant by the appointment of Hon A G Blair as railway commissioner. He was defeated, however, by Dr J W Daniel. In the general elections of 1904 he offered for St John city and county but was not elected. On October 28th, 1907, he was sworn in as attorney-general of the province and was elected a member of the local house for St John county by acclamation on Nov 8, succeeding Dr R C Rudnick, who resigned. At the general elections of 1908 he was returned for the county by a good majority but resigned his portfolio with his colleagues following the defeat of the Robinson government. Hon Mr McKeown is married to Miss Burpee, daughter of Mrs John Burpee, of this city.

Hon Mr McKeown is known as a sound lawyer, and has been engaged in a number of prominent cases. He

has been a spirited and active campaign speaker and worker and has won a reputation for his ability on the platform and in the debates in the provincial legislature. He is able, courteous, numbers many friends and will be warmly congratulated on the attainment of his high position.

J H BARRY, K C

Fredericton, N B, May 23.—(Special)—Jeremiah Hayes Barry, K C, is a son of the late Patrick Barry, and his wife, Julia Hayes, who came to New Brunswick from Bandon (Ire), in the early forties, and settled at Mangerville, Sunbury county, where the subject of this sketch was born on May 21st, 1858. He was educated at the public schools in St Marys and Fredericton and studied law with J A Vanwart, afterwards Judge Vanwart, and was called to the bar in 1881.

Mr Barry practiced his profession in Fredericton on his own account until March, 1887, when the late Hon A G Blair, then attorney general, and he formed a co-partnership and practiced in Fredericton. This partnership continued after Mr Blair moved to St John in 1892 and until he became minister of railways, four years later.

Mr Barry has been clerk of the York county court since 1885, and acted as crown counsel in many important criminal cases during that period. He was appointed judge of probate for York county in September, 1899, succeeding the late Judge Stratton, and has held that office up to the present time. He is a member of the senate of the University of New Brunswick and also of the Provincial Board of Health. He has always manifested an active interest in the affairs of Fredericton and has for some years been a member of the council of the board of trade and trustee of Victoria Hospital. He was appointed King's Counsel in July, 1899, has for a number of years been a member of the council of the Barristers' Society, and is now vice-president of that body. In religion he is a Roman Catholic, and is a member of the C M B A and A O H. Judge Barry married in 1891, Isabella, daughter of John Owens, of this city, and they have four children two girls and two boys. All attend school here.

Judge Barry never entered the realm of politics, although on two occasions he was offered the Liberal nomination for the house of assembly, and was offered the Liberal nomination for the house of commons. He has long been recognized as one of the best and most successful lawyers of this section of the province, and the prominent business men of the city are numbered among his clients. His business dealings have ever been characterized by the strictest honesty and integrity. He is of genial disposition and is easy of approach and popular with all classes of his fellow citizens. He is said to be the first Irish Roman Catholic to be called to the New Brunswick Supreme Court bench.

May Extend Tobique Line.

Would Mean Erection of Large Mills By Stetson Cutler

Michael McDade Talks of Prosperity of Northern Counties.

Michael McDade was in town yesterday on his return from a business trip in the up-river counties of the province. He gave a Sun reporter a quite a batch of interesting news.

Everywhere, he says, in Carleton, Victoria and Madawaska counties he found a greater spirit of hopefulness among the people than ever before. The building of the Grand Trunk Pacific and the approaching completion of the International Railway from Campbellton to St Leonards have awakened the people up-river to the great business possibilities of their sections of the province and new industries are starting in all directions.

The Scottish and Danish settlements in Victoria county and the Irish-Catholic settlement of Johnville have prospered beyond the most sanguine expectations of their promoters; and if the prosperity of the people there could be brought home to thousands of the clerks in our towns and cities, who are obliged to work at moderate salaries, there would be a rush for many of the still vacant farms in the up-river sections.

The most successful Scottish immigrant is of course Donald Fraser, who came with a great number of others

from Scotland some thirty years ago and settled in Victoria county. He was not long in finding an opportunity of engaging in the milling business in a small way at River de Chute, at a point almost between Carleton and Victoria counties. From that small beginning he became the owner of a large mill at Fredericton and is now one of the great lumber kings of the province, owning several mills, two of which (one at Plaster Rock and the other at Cabano, between Edmundston and River de Loup) are as fine as can be found elsewhere in the Dominion.

The Plaster Rock proposition is conducted by the Fraser Lumber Company and is managed by Donald Fraser, Jr. The mill cuts some four-tens millions of lumber each season and most of this finds a market in the United States. Besides the mill, which employs 200 hands, the Fraser Lumber Company at Plaster Rock does a very extensive general business and carries a stock of goods valued at between forty and fifty thousand dollars.

Mr Fraser, Jr, has as his right hand man Kilburn Reid, of Centreville; Robert Crawley, from St George, book-keeper; W C McFarland, Kingsley, York County, assistant bookkeeper; Leo McLaughlin, St John stenographer; Fred Kirkpatrick, St John, store manager; with George Mullin, Stanley, and Miss Maud Hall, chief assistants. C L Bent, Fredericton, is yard boss and Felix Charette is foreman of the mill. The post office is in charge of Michael O'Shea, of Northumberland County, and the Fraser Hotel is leased to and managed by W P Coade, a competent hotel man from Nova Scotia. The business of this company alone at Plaster Rock pretty fully taxes the capacity of the Tobique Valley Railway, which is under lease to the C P R. The condition of the Tobique Valley road might very easily be improved.

There is talk of extending the line a further distance of twenty-eight miles along the Tobique river, and if this be done it is said that Stetson Cutler and Company will erect Cove mills at the other end. The Gypsum mill at Plaster Rock is in operation with an experienced man, John Elgan, in charge. It is being managed by the Fraser Lumber Company and finds ready sale for its output.

Speaking of Johnville, Mr McDade said that Charles E Gallagher, who was among the pioneer settlers of that settlement upwards of forty-five years ago, was one of the most prosperous of Carleton County merchants and was located at Bath. There, also resides Thomas Bohan, who retired with a competency more than a dozen of years ago, largely the result of his integrity, industry and energy as well as his business dealings for more than a quarter of a century with the people of Johnville.

The survey of Johnville was made nearly fifty years ago by James Hartley of Woodstock, father of J C Hartley, Barrister. Among the earliest settlers who are still alive are Moses Brennan, Thomas McGinley, Alexander Hall, William Gallagher, John Kilfoil, Patrick O'Neil and James Colton.

Rev Father Coughlan, parish priest

of Johnville, is a great favorite with all classes and creeds. There is a vigorous branch of the Ancient Order of Hibernians at Johnville, and its members are still enthusiastic over John O Ferguson's St Patrick's Day address there. C F Gallagher is the A O H county president of Carleton county, and his name is frequently mentioned as a candidate for the local legislature. For years there had been a hope that John W Bohan of Bath would have sought legislative honors, but he has preferred attending strictly to business, being one of Carleton county's prominent produce dealers.

"There is a very general impression," said Mr McDade, "indeed I might say a general fear among Carleton county Liberals that Frank B Carvell, M P, will accept a supreme court judgeship. It is not too much to say that Mr Carvell is the idol of his constituents and that his name stands among them for integrity and honor. Should Mr Carvell become a judge there is a feeling that Andrew McCain of Florenceville, son of H H McCain, ex M P P, might be permitted an election by acclamation, but that any other candidate will be strenuously opposed by the Conservatives.

"East Florenceville," said Mr McDade, "is one of the busiest centres for the shipping of farm produce in the whole of Carleton county. The chief shippers include John Bohan, H H McCain, B Frank Smith, James McIsaac and C E Gallagher. The extent of their business may be judged from the fact that the exports from this point last year exceeded half a million of dollars and the shippers look for bigger business this year. The Bank of New Brunswick has a branch at Florenceville, the manager of which is Richard Dole, son of our respected townsman, Dr W P Dole." St John Sun.

Grand Lodge I. O. F. in August.

Local Lodges Have Chosen Their Committee to Make All Preparations—An Excursion on the River to Form Part of Programme—Other Arrangements.

On invitation of the four St John lodges, the Grand Lodge of Oddfellows of the Maritime Provinces will meet in St John during the second week in August. This will mean an attendance of probably upwards of four hundred delegates from every part of the provinces.

On Tuesday, Aug 10th, the Grand Encampment and the Rebekah Assembly will hold their annual sessions, and the usual committee work of Grand Lodge will be completed.

On Wednesday forenoon the Grand Lodge will open, and will continue in session until Thursday night.

The St John lodges have begun preparations for this big and important gathering; the different lodges have appointed representatives to the Grand Lodge committee, and this body last evening held its first organized business meeting. H E Codner was chosen chairman and Chas Ledford secretary.

In view of the fact that a very considerable amount of business must be handled by Grand Lodge this year, there will not be opportunity for much entertainment, but it has been arranged that the visitors and friends as well as local members of the order, will enjoy an excursion up river. The steamer Victoria will be engaged to leave North End at 3 p m on August 11th, returning between six and seven o'clock. There will be a band on board and refreshments will be served.

The meeting last evening appointed sub-committees to deal with the different lines of preparation, and these will all report at a meeting to be held on Tuesday evening, June 8th, in Peerless Lodge rooms, Simonds St.

Definite arrangements about the meetings of the Grand Lodge will be made in a day or two, but it is probable that the sessions will take place in the Keith assembly rooms.
