FASHION NOTES

DRESSY CHIFFON WAISTS. Chiffon still holds a prominent place in the construction of dressy blouses, but this material is combined with satin, fancy silks and nets to a greater extent than was the case last season. The chiffon is used mostly in subdued colorings, the other materials used showing either white or bright color touches. Satin girdles finish off the waist of many of the more expensive blouses, thus making the garment suitable for wearing over a dress skirt.

ROBESPIERRE COLLARS. Modified Robespierre collars continue the foremost sellers of the current season, and new versions are in process of development for early fall styles. Opinions differ somewhat as to the continued popularity of the Robespierre features, some makers holding that they will be "done to death" before the new season appears. The influence of this style, however, will surely be felt, even if only in so remote a fashion as to be scarcely recognized.

NARROW PLEATED SKIRTS.

The fall lines of dresses include many models made in some form of pleated skirt. In every instance, however, they are straight and narrow. The pleats extend to the waist in some of the samples, but other styles show pleated panels or deep pleated flounces. When the pleats extend only to the knees a modified panter drape finishes the upper skirt section.

FLORAL GARNITURES.

Although corsage flowers have been quite popular for the past season or two, present indications point to even greater popularity for garnitures of this kind. Paris is especially strong on the floral garnitures, which are being worn there, in smaller sizes than formerly, underneath hat brims, of coat lapels, at the corsage line or as a finishing touch for draped effects.

WHITE SHETLAND LEADING ITEM.

White Shetland continue to be the liveliest article in the veiling market. Shadow designs in infinite variety, both in floral and in scroll effects, have met with success, but the demand is narrowing down to the daintier shadow numbers, those that are most suggestive of coolness and comfort. Some particularly snooty cobweb designs are finding favor.

SUPREME COURT JUDGMENTS

Fredericton, June 21—Judgments were given by the supreme court today as follows:

In case of O'Regan vs. C. P. Railway Company, appeal followed to set aside a verdict for a plaintiff and enter a verdict for the defendant. The court was unanimous.

In cases of McClathrin vs. Jamer and Ralston vs. Jamer—The judgment of the court is to set aside the non-suit and to enter a verdict for \$15 for the plaintiff in each case.

In case of St. John River Steamship Company Ltd. vs. Crystal Stream Steamship Company Ltd.—The court gave judgment sustaining the decision of Judge Landry and dismissing the appeal with costs.

In case of Connelly et al vs. Trustees of School District No. 8, parish of Havelock—Judgment was that the lien on the school building in that district granted the plaintiffs be affirmed and the appeal dismissed with costs.

In case of Jack vs. Carney et al—Appeal allowed with costs and judgment was ordered to be entered for the defendant in the court below.

In case of the King vs. Matheson, ex parte Shilala—Rule was discharged and conviction affirmed.

In case of the King vs. J. W. Taylor, justice of peace for the county of York—Judge Barry granted an order nisi to quash the conviction of Graham and Embleton under the Canada Lord's Day Act, and no one appearing to support the conviction the rule nisi was made absolute.




