WILLARD H. BERRY RETURNS

More Crooked Work Exposed—Serious Charges Preferred—What Will Acting Premier Clarke Do About It?—More People Than Premier Fleming Afraid of Berry's Evidence

The public announcement of the return of William H. Berry to the province seems to have created a sensation. The man who fled from New Brunswick the very day the Royal Commission began its work, after a conference the day before with Premier Fleming on the train between McAdam and St. Stephen; the man who refused to obey the order of the Royal Commission to attend and give evidence; the man who later returned to Calais and remained just across the border line almost listening to the revelations against his premier and the head of his department, as soon as the investigation closed calmly returns to his home and says: "What are you going to do about it?"

It remains to be seen whether he will remain to face the more serious charge publicly made against him by Liberal Organizer E. S. Carter, of having been a party to defrauding the provincial revenues of \$2,903.32. In plain language, this money was stolen from the Crown Land Department and the government cannot refuse to investigate the facts and prosecute the men who are charged with the misdemeanor.

In Mr. Carter's interview with The Mail on Wednesday his statement was broad but without detail. Since then, many of these of a convincing character have been obtained.

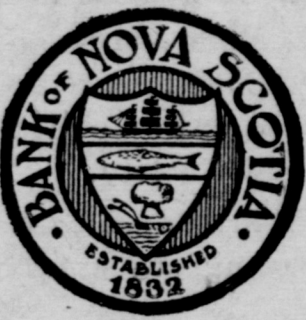

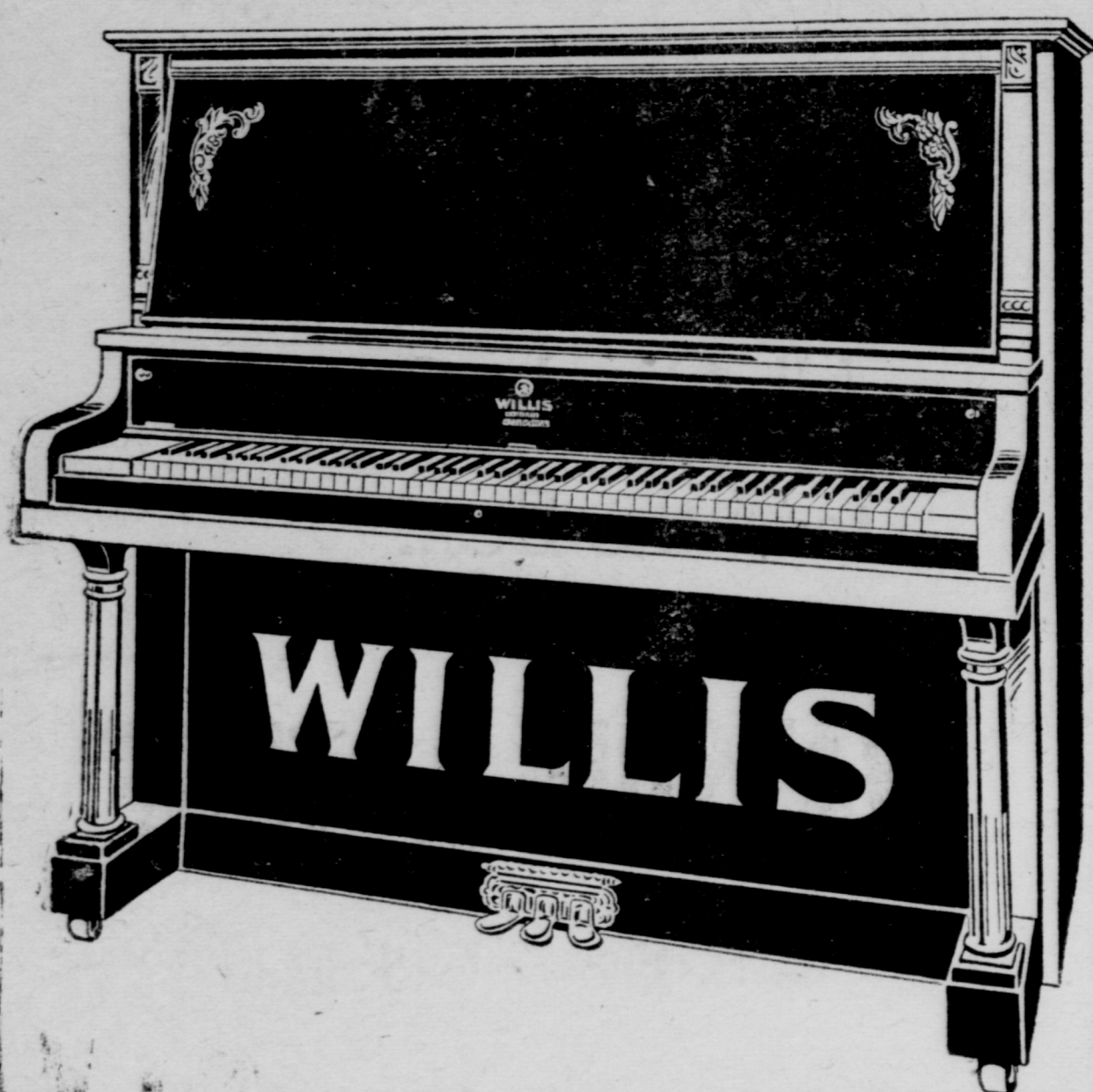
