#### Mystery of the American Lakes.

Lake Erie is only sixty or seventy feet deep; but Lake Ontario, which is 592 feet deep, is 220 feet below the tide level of the ocean, or as low as most parts of the gulf of St. Lawrence; but the bottoms of lakes Huron, Michigan, and Superior, although their surface is so much higher, are all, from their vast depth, on a level with the bottom of Ontario.
