TO THE EDITOR OF THE REVIEW.

The appointments in this County re cently made by the Local Government have caused no little surprise and unfavorable comment, and will doubtless occcasion much more as the information spreads through the County in the columns of THE REVIEW.

The selection is, to say the least of it somewhat extraordinary and the wonder is who can be held responsible for the recommendation, or how the Government could have been induced to so flagrantly violate the spirit of the law as they have done in at least one instance amongst the

It is to be hoped that the present re presentative of the County is not in any way responsible.

The Liquor License Act of 1887 provides that "no licensed tavern keeper shall be qualified to be appointed to or hold a place in the Commission of the Peace and any person holding any such office shall on application for a tavern license under the Act, be held by virtue thereof to have violated and forfeited such office and the same shall ipso facto upon such application become absolutely forfeited, vacated and annulled.

Now it is notorious that one of the newly appointed J. P.s is proprietor of the Kent Hotel, which has a bar in connection with it run by Mr. Woods. It is true that for ulterior purposes the license was taken out in the name of his son, a minor; but Mr. Woods is the virtual licensee. What then can be said of the Government which with these facts in their knowledge have appointed him to the Bench of Magistrates of this County as one of the conservators of the peace and guardian of the law? It may be that the reputation he has earned in the political contests of this County of late years through his alleged connection with the Cocagne Ballot Box escapade, the fight at Richibucto Village and other similar exploits of unsavory notoriety, have served in the estimation of the Grit leader of the Local Government to qualify him for the supposed honor, but surely even these "qualifications" would not justify such a gross outrage of the law as the appointment of a licensed hotel keeper to

However, I regret to say that this is not the only instance in which such a flagrant wrong has been done in this county.

There is another example in Buctouche in case of the stipendiary magistrate, Mr. D. D. Landry, who is also the proprietor of an hotel, and who, with the hope of evading the law, adopted the expedient of taking out a license in the name of his wife, which, I understand, the clerk of the peace advised the Municipal Council, was clearly illegal. This party also received his appointment as J. P. in direct violation of the spirit of the law. Possibly he too had other "qualifications" in the eyes of Mr. Blair by reason of his good reputation

in election contests in this county. The appointment of Parish Court Commissioner for Weldford will no doubt form a great surprise to the Bass River J. P. who had been promised the position, and whose experience on the bench and knowledge of law certainly gave him superior claims. The extraordinary part of the appointment, however, is that, as I am informed, the late incumbent (Mr. Brown) is only temporarily absent from the Province, and a piece of deception has been practised upon the government to secure the position for Mr. Burns. The appointment of the "boy J. P." and the issuer of marriage licenses at Weldford station are no doubt the fruits of the recent secret visit of Messrs. Bailey and Woods to Fredericton during the recent session of the legislature. Whether the selection is such as will commend itself to the people of that locality is, in my opinion, somewhat doubtful.

### DOMINION PARLISMENT.

OTTAWA, April 30.—The members of the House of Commons were sworn in yesterday forenoon, and in the afternoon met to select a speaker. Sir John Macdonald nominated Peter White for the speakership, eulogizing him as a man of experience and one in whom all parties could have confidence. Sir Hector Langevin seconded the motion.

The speaker was then declared elected. After he had returned thanks for the election the House adjourned.

This afternoon Parliament re-assembled, and the Governor General read the speech from the throne, which was as follows: Honorable Gentlemen of the Senate: Gentlemen of the House of Commons:

I am glad to welcome you to the duties of the first session of a new parliament, which I hope will be memorable for wise deliberations and for measures adapted to the progress and development of the Dominion.

The season in which you are assembled has opened auspiciously for the industries of our people. Let us hope that their labors may be crowned with fruitful returns from land and sea and that the great resources of Canada may continue to reward the toil and enterprise of its inhabitants.

My advisers, availing themselves of apportunities which were presented in the closing months of last year, caused the administration of the United States to be reminded of the willingness of the government of Canada to join in making efforts for the extension and development of the trade between the republic and the Dominion, as well as for the friendly adjustment of those matters of an international character which remain unsettled. I am pleased to say that these representations have resulted in an assurance that, in October next, the government of the United States will be prepared to enter on a conference to consider the best means of arriving at a practical solution of these important questions. The papers relating to this subject will be laid before you. Under these circumstances, and in the hope that the proposed conference may result in arrangements beneficial to both countries, you will be called upon to consider the expediency of extending, for the present season, the principal provisions of treaty, 1888, known as the "modus

A disposition having been manifested in the United Kingdom to impose on seagoing ships engaged in the cattle trade increased afeguards for life and greater restrictions against improper treatment, a careful enquiry has been made as to the incidents of that trade in so far as this country is concerned. The evidence elicited on this enquiry will be laid before you. While I am glad to learn that our shipping is free from reproach in that regard, your attention will be invited to a measure which will remove all reasonable apprehensions of abuses arising in the future in connection with so important a branch of

The early coming into force of the Imperial statute relating to the vice-admirally courts of the empire has made it necessary to revise the laws in force in Canada repecting our courts of maritime jurisdiction, and a measure will therefore be laid before you designed to re-organize those

A code of the criminal law has been prepared in order that that branch of our jurisprudence may be simplified and improved, to which your best attention is in-

Measures relating to the foreshores of the Dominion, and to the obstruction of its navigable waters, will be submitted to you, and you will also be asked to consider amendments to the acts relating to the Northwest territories, to the exchequer court act, and to the acts relating to the

The accounts for the past year will be submitted to you. The revenue, after providing for the services to which you appropriated it, has left a surplus for the by capital expenditure. The estimates for the coming year will be laid before you at an early date.
