THE OUTLOOK.

Notwithstanding the efforts of Mr. Blair to prevent the people having a voice in the choice of their representatives, the opposition have already succeeded in putting a complete ticket in the field in nearly every constituency. It will be remembered that when the government last appeared to the country, the elections were sprung at such a season of the year, and so suddenly, as to leave the opposition scant time to select their candidates in the different counties. In this way, Mr. Blair succeeded in gaining a number of seats he would otherwise have failed to carry. In Restigouche, Gloucester, Charlotte, Kings, Queens and Madawaska, the government succeeded in electing fourteen supporters by acclamation. In Sunbury, the opposition had only one candidate in the field, and in Carleton Dr. Atkinson ran alone against two government supporters. In York there were but two opposition candidates for the four seats. It will thus be seen that in 1890 Mr. Blair secured eighteen seats through the negligence of the opposition in not putting candidates in the field. Of the twenty-three contested seats, the opposition captured nineteen. Mr. Blair has made an attempt to play the same old game by again springing the elections on very short notice. It does not look, however, as if the opposition have been caught slumbering on their rights. In several doubtful counties the premier has endeavored to make "deals" by which he hoped to secure supporters without the formality of a contest. Except in the case of Charlotte County, however, he has not met with much success. In that county, Mr. Hill announced his intention of forming an independent ticket to contest the constituency, Mr. Blair in his desire to avoid a contest which would probably have proved disastrous to him, got over the difficulty by displacing one of his own supporters and giving Mr. Hill a place on the government ticket as an independent supporter of the government. In several other counties arrangements of a similar nature proposed by the government were rejected. From all over the province come encouraging reports of the prospects of the opposition. In some counties, such as St. John, Mr. Blair has taken it upon himself to place in the field, without even consulting his friends, men with no chance whatever of success. In Albert, Hon. Mr. Emmerson is the only government supporter, and no government candidates have as yet been named in the County of Sunbury. Altogether it looks very much as if Mr. Blair will be found in the opposition benches next session, if, indeed, he is fortunate enough to secure his own election in York.

MR. BLAIR'S METHODS.

A glance at Mr. Blair's political career will not tend to raise him in the estimation of those who believe in administering our provincial affairs honestly and constitutionally. It has been again and again charged against him in the Assembly and through the public press that he first gained power through the purchase of a gentleman who now occupies a seat in his government. Since then the history of his government has been one of extravagance and corruption. Who has not heard of the Northumberland deal, by which four representatives of a county were bought to support a government in which the electors of the county had most emphatically declared they had no confidence? In fact ever since its formation the Blair government has been fraudulent in deal. The Northumberland deal is only one of many. Mr. Blair's last deal by which he purchased an opponent in Westmorland county by the disposal of a seat in the executive is too fresh in the minds of the public to need mention. The people of this county were last summer brought into pretty close contact with Mr. Blair and his methods, and it is needless to say they are not in love with them. They cannot but ask, where did all the money come from that was brought into the county to secure the election of Mr. Legere? There can but be one answer to this question; it came directly or indirectly from the provincial treasury. It is easy to understand then why the treasury is so empty and why Mr. Blair is compelled to resort to direct taxation to keep the province in funds. Thoughtful people must have long ago arrived at the conclusion that the sooner Mr. Blair and his colleagues are replaced by honest men the better will be for the province.

The Saint John Globe says: "Dorchester has been a place of importance, but it is doubly so now, for this little town has in the government two members, and office-holders at that. The Hon. H. R. Emmerson, Commissioner of Public Works, and Hon. A. D. Richard, Solicitor General, who hail from that place, were sworn in on Monday. It seems upon the face of things that it would be much better to make Mr. Carleton, who is running in St. John city, Solicitor General, and put him in as a candidate in the county, where he would be pretty sure of election. To take two members of the administration out of the little village of Dorchester, is of course, a great compliment to that place, but it seems hardly fair to the other parts of the province."

We do not know what claim Mr. Carleton may have to a position in the government, but we do know that it would have been much better for Mr. Blair, had he redeemed his promises to the people of Kent to give the county three representatives in the Assembly. He could then have given Mr. McInerney a place in his government and have thus redeemed another promise. He chose however, to ignore the county and its rights, and the electors will give forth no uncertain sound on the 22nd.

The government party have had a hard time in getting candidates in Westmorland but it appears that they have at last succeeded in getting a full ticket. The names first proposed were those of Sumner of Moncton, Fawcett, of Sackville, Smith of Dorchester and Solicitor General Richard. Mr. Sumner, however, sought a place on the opposition ticket and Mr. Fawcett refused to become a candidate. When this became known, the names of Messrs. Richard, Smith, Killam and Copp, were published as the government ticket. Mr. Smith, who was absent when the nomination was made, wired a non-acceptance but he was afterwards induced to alter his determination. In the meantime, Mr. Copp handed in his non-acceptance, and the committee was obliged to look around for some one to take his place. The selection fell upon Mr. W. Woodbury Wells, of Baie Verte. As it now stands the government candidates in Westmorland are Messrs. Richard, Killam, Smith and W. Woodbury Wells.

The St. John Sun has the following to say concerning political matters in Kent: "The joint card of Mr. J. D. Phinney and Mr. J. B. Gogain, the opposition candidates in Kent, appears in the Moncton Times. This is the same opposition ticket which appeared in 1890, when Mr. Phinney was elected and Mr. Gogain was defeated by a small majority. At that time the government candidates were Mr. Oliver LeBlanc and Mr. McInerney, a much stronger combination than Mr. Blair can get now. The government would have been more than willing to allow Mr. Phinney an election without opposition if he and his friends would accept a ministerialist colleague. It did not take long to discover that Mr. Phinney is not that kind of a man. The government has not yet found a colleague for Mr. Legere."

Mr. Barnes has since joined Mr. Legere, and the ticket will be Legere and Barnes. The Sun is correct in saying that the combination is much weaker than the government ticket in 1890. It will be buried under an immense majority on the 22nd instant.

It appears that the Dominion government has for reasons best known at Ottawa, suspended several fishery officers in the southern part of this county and it is sought to injure Mr. Phinney by charging that, as he has the federal patronage of the county, it is he who is responsible for the government's action in the matter. Mr. Phinney is not the adviser of the authorities at Ottawa in Kent matters. Since the death of Doctor Legere, M. P., Senator Poirier, of Shediac, has been looking after the federal interests of Kent Co., and if anyone deserves blame in the matter it is Senator Poirier and not Mr. Phinney. It is probable that neither of them was consulted, but that the action of the government in the matter was due to the report of fishery officer R. A. Chapman, of Moncton, who went through the county a short time ago, looking after the oyster fisheries here.

Mr. Legere and Mr. Barnes have reached Richibucto, and they have wonderful stories to tell about their strength in the southern part of the county. In St. Mary and Dundas, they had the same story to tell about the northern parishes. Everything was sold for the government up this way. It is always some other parish than the one they are in that is going to roll up such a wonderful majority for them. In Dundas they stated positively that Mr. McInerney and his friends were strong supporters of the government, and that Mr. McInerney would stamp the northern parishes in their interest. It is probable that Mr. McInerney will be heard from in this election, but not as a supporter of Messrs. Legere and Barnes. He will do all he can to help elect Phinney and Gogain.

Lawyers are generally a pretty good class of citizen, but that is no reason why the affairs of the country should be in their hands exclusively. The St. John Sun calls attention to the fact that the five executive officers of the local government are filled by lawyers, as follows:— Attorney General.—Hon. A. G. Blair, barrister, Fredericton.

Solicitor General.—Hon. A. D. Richard, barrister, Dorchester. Chief Commissioner of the Board of Works.—Hon. H. R. Emmerson, barrister, Dorchester. Provincial Secretary.—Hon. James Mitchell, barrister, St. Stephen. Surveyor General.—Hon. L. J. Tweedie, barrister, Chatham.

A full opposition ticket has been nominated in York, and Attorney General Blair will have to do some hard work to gain his own election. Mr. Wm. K. Allen, a son of the chief justice of our supreme court leads the ticket. His associates are Mr. Howe, an ex-warden of the county, Mr. Pinder, who has for several years occupied a seat in the York County Council, and Mr. Pitts, who was nominated a few days ago by the temperance people, and is now endorsed by the opposition. The government ticket is made up of the four old members.

The St. John Sun says: "Another independent member, who refused to be Mr. Blair's man, was Mr. Phinney, of Kent, one of the best men who has ever been in the House of Assembly. Failing to coerce Mr. Phinney, Mr. Blair threw the whole weight of the government upon him at the next election. Mr. Phinney was not destroyed. He came back to the house with a majority over Mr. Blair's minister. To-day Mr. Phinney is in a position to refuse Mr. Blair's overtures, and the attorney general is hardly able to form a ticket in Kent."

Mr. Blair and Mr. Mercier have been frequently classed as "birds of a feather." In this a great injustice has been done Mr. Mercier. He may have been corrupt, but it can never be charged against him that he deserted his friends. With Mr. Blair it is different—his best gifts have been bestowed on his enemies, with the hope of buying them over. His friends are treated to the crumbs.

Mr. Phinney conducted the proceedings for the opposition in the Balcom draft inquiry before a committee of the legislature at Fredericton last session, and he did the work so well that Mr. Blair used up a great part of his speech in St. John a few evenings ago endeavoring to explain away the ugly looking facts as they appear upon the records.

In Kings, Messrs. A. J. Kerstead, Geo. W. Fowler and John Gilchrist have been nominated as the opposition candidates. In Carleton, Mr. Blair has selected Messrs. A. C. Caldwell and Charles L. Smith to run as government supporters. Dr. Atkinson and his colleague are expected to have an easy victory.

The Moniteur Acadien, of Shediac, strongly supports the opposition. Concerning Kent it says: "Mr. J. B. Gogain is on a ticket with Mr. Phinney. It is a powerful combination, and the friends of good government and political honesty should support and elect the ticket."

The Moncton Times says: "Hurrah for Phinney, Gogain and Honest Government!" That is just about the way the people of Kent feel. They intend to elect these two gentlemen to represent the county in the next legislature.

Messrs. Phinney and Gogain were in Cocagne last Friday and Saturday. Mr. Phinney writes that the parish of Dundas will cast an almost solid vote for Phinney and Gogain.

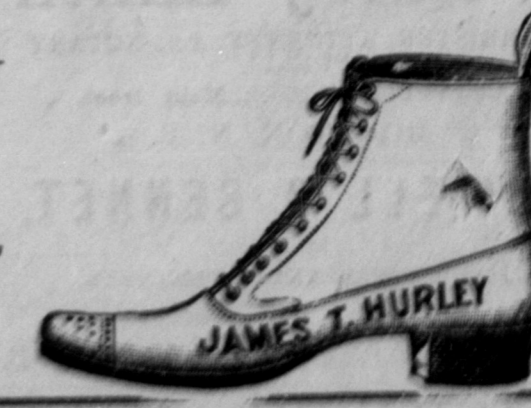
