EQUITY COURT.—At a sitting of the Equity court, held in St. John last Wednesday, before His Honor Justice Palmer, Mr. E. McLeod, Q. C., appeared for the plaintiff in the case of George K. McLeod vs. John Curran et al, Mr. C. A. Palmer, Q. C., for John Curran and Mr. J. D. Phinney for Thomas McWilliam and Clarence T. Curran. On Motion of Mr. McLeod the bill was taken pro confesso for want of an appearance against Mrs. John Curran. The suit was brought for the Accommodation for Campbellton, foreclosure of a mortgage and the sale of lands situate in Restigouche county. The plaintiff claimed that the mortgage was made for \$265 by Mr. Curran to Messrs. C. M. Bostwick & Co., that then Mr. Curran sold one-half of the property to plaintiff, and the plaintiff claimed that he then paid off the mortgage and C. M. Bostwick & Co. assigned it to him. Mr. Palmer said subsequently a deed was made from Mr. Curran to Mr. Thomas McWilliam and Mr. C. T. Curran of the other half for \$2000. The defendants claimed that the plaintiff and Mr. Curran went into partnership in the milling business and that there was an agreement that the purchase money of \$2,325 and the sum of \$350 which Mr. McLeed owed Mr. Curran at the time, were to have been paid to C. M. Bostwick & Co. for a discharge of the mortgage, but that instead the plaintiff obtained an assignment which he placed on record. The plaintiff denied these allegations in toto. His Honor said that as there appeared to be a pretty sharp issue of fact to be tried he would call a jury, the issues to be drawn up at trial by consent of the parties. The case was then adjourned until Thursday morning, when the counsel announced to the court that a settlement had been effected in the

The School Inspectorship.

RICHIBUCTO, Aug. 10.—The School Inspectorship question is causing no little amount of discussion in this county. It has been reported that Inspector O'Brien, whose territory includes Kent and Madawaska, is about to resign, and petitions are being circulated asking for the appointment of Pius Michaud, nephew of Rev. Father Michaud, of Buctouche, in the event of a vacancy. It is said that these petitions were presented for signatures in the vestries of all the Catholic churches in the two counties last Sunday. Young Michaud holds a first class license from the Normal School, but has not been teaching for the quired period of five years. Still it is ul that this point has not been insisted on in the cases of other inspectors. The fact that Michaud is only 22 years old may interfere with his chances, but with the backing of the French Canadian population of Kent and Madawaska his friends hope to see him appointed.—Transcript.
