Justice's Court.

An action brought by Robert Lennox against James McLelland, was tried before Justice H. M. Ferguson, at Kingston last Thursday. McLelland, who ran a threshing mill last fall, worked at plaintiff's barn. After his threshing was done, Lennox helped move the machine to the barn of Wm. Main, in Galloway, and brought this action for doing so. Defendant contended that in helping to move the machine, plaintiff was doing only what he had offered to do before the thresher went to his barn. Plaintiff appeared in person, defendant by Wm. D. Carter, his attorney. The jury gave a verdict for defendant.

Obituary.

It is our painful duty this week to record the death of Miss Agnes Stevenson, niece of Mr. John Stevenson of this place and for the last three years a member of his household. Deceased came to Richibucto with her grandfather, John Stevenson, Sr., when he moved here a few years ago. She first attended the Grammar School here and afterwards the Normal School Fredericton, where she successfully passed her final examination and obtained a license to teach. Consumption set in before she had taught many months and she was obliged to return to her home where she died last Thursday. She was 21 years of age and highly esteemed by all who knew her. The funeral—one of the largest ever seen in Richibucto—took place Sunday. The pall bearers were Fred E. Sayre, W. E. Forbes, Fred Ferguson, Wm. Hudson, Jr., George Amercaux and R. A. Irving. The floral pillow and cross presented by the teachers were very beautiful. The services at the house, St. Mary's church and the grave were conducted by the Rev. Henry Hackenley, who was very attentive to her during her long illness. May God comfort her sorrowing sister, brother and other relatives.

Circuit Court.

The Kent Circuit Court opened here on Tuesday, the 8th instant, Chief Justice Allan presiding. The following causes were entered for trial:—

- 1. Thomas Flanagan vs. William Wheten. C. Richardson filed record.
2. Joseph Killian vs. Bowen Smith. C. J. Sayre filed record.
3. George K. McLeod vs. Thoms Gill et al. E. R. McLeod & Ewing filed record.
4. John W. Harnett vs. Henry O'Leary. C. Richardson filed record.
5. Doe dem A. J. Girvan vs. John D. McMinn. C. J. Sayre filed record.

In the first cause, Flanagan vs. Wheten, each party filed a record and summoned a jury. The cause went to trial on the record filed. This was an action of replevin brought by Thomas Flanagan of Chatham against Sheriff Wheten. The facts are briefly as follows:—About a year ago, defendant, as sheriff, seized the goods in the store of Martin Flanagan, of Richibucto, under an execution against him, in which Messrs. McDougall & Son, of Halifax, were plaintiffs. Thomas Flanagan claimed the goods under a bill of sale given him by his brother Martin, and therefore brought on an action against the sheriff. A sheriff's jury gave the possession of the goods to Flanagan, pending the trial of the cause. The result was a verdict for defendant of \$1200. C. Richardson, Geo. V. McInerney and R. A. Lawlor for plaintiff, and C. J. Sayre, W. W. Wells and J. S. Covert for defendant.

Killian vs. Smith and McLeod vs. Gill et al were settled.

Harnett vs. O'Leary was referred to arbitration.

Doe dem Girvan vs. McMinn was an action of ejectment. Verdict for plaintiff with leave reserved to defendant to enter a new suit. C. J. Sayre for plaintiff, R. Hutchinson and Wm. D. Carter for defendant.

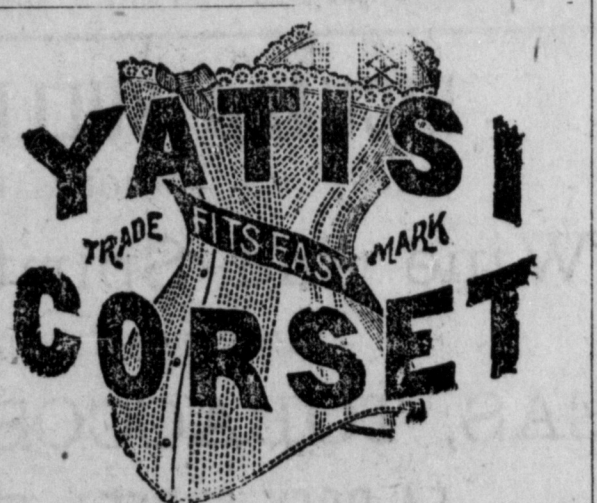

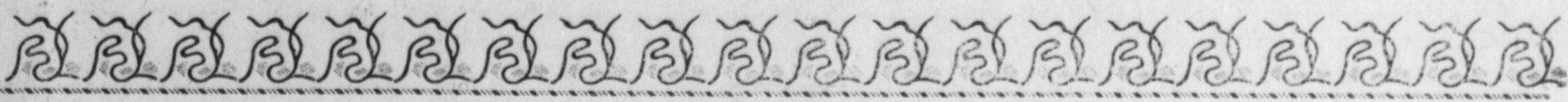
