PHINNEY. It is rather amusing to read the attacks made upon Mr. Phinney by the Acadian press, for what they are pleased to term his treachery in supporting Mr. McInerney in the late election. To read these journals one would suppose that Mr. Phinney owed his political existence entirely to the Acadians of the county. They accuse him of the basest kind of ingratitude because he saw fit to refuse his support to Mr. Johnson. And the strangest part of it is, that the Acadians who are loudest in their denunciations are those who have in the past worked hardest to defeat him. If our Acadian friends take the trouble to think the matter over we believe they will arrive at the conclusion that they owe more to Mr. Phinney than he owes to them. If they will but recall the election of 1887, they will be forced to admit that Hon. P. A. Landry was for his success in that contest, largely indebted to Mr. Phinney. A change of 175 votes would have defeated Mr. Landry, and no one will by Councillor McAlmon, that the finance deny that he secured at least that number of votes through the efforts of Mr. Phinney and his friends. Then again in 1890 Councillors McKee, Legere, Murphy, Dr. Legere would have stood a slim chance of election had it not been for Mr. Phinney. On the other hand, how has Mr. Phinney fared in his elections at the hands of the Acadians? In 1890 when he and Mr. Gogain were opposed by Messrs. McInerney and LeBlanc, a majority of the Acadian votes of the county were cast in favor of Mr. McInerney. Again in the last local contest the majority of the Acadians showed their gratitude to Mr. Phinney for past favors by voting for his opponent Mr. Legere. Where, then, does Mr. Phinney's ingratitude to the Acadians come in? And above all why should he be asked to support Mr. Johnson? No doubt, the rule "Do good unto your enemies" is the correct one to pursue in general. In politics, however, it has been found inconvenient to follow. From the time Mr. Phinney first entered public life, he has found Mr. Johnson's nearest friendamong his bitterest enemies. They have sought on every occasion to injure him. In the last local election Mr. Johnson evinced a decided hostility towards Mr. Phinney until he secured the Dominion nomination at the Buctouche convention. He then deemed it prudent to hold himself aloof from the contest, but his friends were as noisy and demonstrative as ever in their opposition to Messrs. Phinney and Gogain. Notwithstanding all this, we are told that Mr. Phinney betrayed his Acadians friends, because he did not rally to the support of those who had done their utmost to kill him politically. We would respectfully remind our Acadian friends who are having so much to say in this matter that they would have fared but poorly in this county in the past, had it not been for the services of Mr. Phinney and his friends, and they may have occasion to again seek his assistance. We are pleased to be able to state, however, that the Acadians who have so manfully supported Mr. Phinney in the past have no sympathy with these childish com-

RELIGIOUS PREJUDICES.

An attempt has been made to create a prejudice against Sir John Thompson by holding him up to the public gaze as renegade Protestant. We have had occasion, in referring to political affairs in this county, to protest against the introduction into politics of race and religious issues. We have contended, and do contend; that a man's religion or nationality should not promotion, and we see no reason why the same rule should not apply at Ottawa. The attempt to arouse religious prejudice against the new premier has, we are pleased to state, altogether failed in North Hastings, a purely Protestant constituency, where a supporter of the governhas just been elected with a majority nearly double that given him at the last general election.
