

Four Persons Burned To Death.

One of the saddest events that has occurred in this country since the Miramichi fire, was that which took place on Monday night. 6th inst., by which James Flynn, a well known farmer and lumberer, of Upper Bay du Vin, his wife and infant child, also an adopted girl aged 6 years, daughter of Mr. Anthony Daley, perished with a burn-




