THE BEHRING SEA DISPUTE.

The attention of the Behring Sea Arbitration Commission has for the past few days been occupied in hearing the arguments of Counsel. Mr. Carter, who is presenting the American case, seems to have gone into the matter pretty fully and to have argued the case from every standpoint. His main argument, however, was based not so much upon the question of territorial jurisdiction as upon the claim of the United States to a proprietory right in the seals frequenting these waters. These seals, he contends, Johnson intends going to the States. are not animals feræ naturæ but the private property of the United States government. By it they were guarded and protected, and, therefore, a species of hus- tie bandry was formed, giving the property right in the seals to the United States. Great Britain, he argued, was doing everything in its power to exterminate them, while the very existence of seal life in these waters to-day is due to the fostering care of the American government. He declared that when it was proved that the wholesale slaughter of these animals by the British sealers was exterminating the species it became the right and the duty of the United States to interfere and protect its rights. Mr. Carter will be followed by another United States lawyer, after which counsel for Great Britain will be heard, leaving to the third United States lawyer the right to reply and close the argument. by the commission in hearing the argu- his trouble. ments and reading the evidences.

THE NEXT GOVERNOR GENERAL.

The Earl of Aberdeen has been appointed governor general of Canada. His term will not, however, legin until September when Lord Stanley's term of office expires. He is now on his way to Canada, and will spend the time between this and September visiting his ranche in British Columbia and the World's Fair at Chicago. The following sketch is given of the career of the new viceroy :-

The Right Honorable John Cambell Hamilton Gordon, seventh earl of Aberdeen was born August 3rd, 1847. He is the grandson of the earl of Aberdeen, who was prime minister in 1854, and nephew of the Hon. Arthur Gordon, who was lieutenant governor of this province at the time of confederation. He was educated at the college hall in connection with the University of St. Andrews, and at University College, Oxford, where he graduated M. A. in 1871. He succeeded to the title on the death of his brother, January 27th, 1870. He entered the House of Lords as a Conservative, but in the session of 1876 he disagreed with some of the principal measures of the party, and in 1879, when the earls of Derby and Carnarvon resigned offices, Lord Aberdeen heartily supported them. In 1880 he had become a recognized member of the Liberal party and was appointed lord lieutenant of Aberdeenshire. In 1886 he was appointed by Mr. Gladstone lord lieutenant of Ireland, for the purpose of carrying out the home rule policy of the government. Lady Aberdeen, to whom he was married in 1877, is the youngest daughter of Dudley-Coutts, first Lord Tweedmouth. She, like her husband, takes an active interest in all philarthrophic movements.

Despite the threats of rebellion in Ulster and the opposition of the British Conservatives in the Commons and out of it to the measure, the Home Rule bill has passed its second reading by a vote of 347 to 304, a majority larger than the majority with which the government met the new House. The second reading as a rule decides the fate of a bill in the British Commons and it may be taken for granted that the bill with perhaps a few minor amendments will pass its third reading and be sent up to the House of Lords. It is equally certain that the Lords will reject it. A dissolution will be the probable result and the battle for Home Rule will have to be fought over again in the constituencies. Should the people declare their approval of the measure the Lords would not dare reject it a second time. Should they do so, however, it would be an easy matter for the government to send a sufficient number of new men friendly to the bill into the House of Lords to pass it despite the opposition of the present members of that body.
