But even these figures do not tell the whole truth; for if protection carries out the design of those who set it up, it must have tended to lessen the exports and imports, as regards the volume of trade which passes through the custom houses, by en couraging the manufacture in the country of a large number of products previously taken from abroad; and by expending among our wage-earning population the large sums paid for imports. Again there has been a decline in the value of goods in late years equal to one-third, so that even these figures do not represent fully the large increase which the country has made in the past ten years, and their point was that he was glad to find the farmers of Canada putting into manufactured products a large number of the national products of the country; so that even some members of the House might be surprised to learn that in 1892 the dairy produce exported to England amounted to \$12,708,407, while during the same period the United States exported to the old country \$11,038,834; in other words the sixty-five millions across the line exported but three-fourths as much as the five millions on this side of the boundry. CAREFUL MANAGEMENT.

As to revenue and expenditure the receipts on account of consolidated fund were \$36,921,871 and the expenditure \$36,765,894, leaving a surplus of \$155,977, which shows that the finances of the country have been carefully looked after and no vast amount has been taken out of the pockets of the people beyond what was required to carry on the great public works. But the figures for the six months ending December 31st, 1892, show that the receipts were \$18,559,024, and the expenditures \$13,842,497, showing plainly that the admirable progress of the country is being maintained. He congratulated the minister of railways and canals on the fact that his management of government railways had brought an annual deficit of half a million down to about \$7,000, and that without entailing the service on the Intercolonial, which, it must be remembered, is the bond of union between the Maritime Provinces and the Western Provinces of the confederation. Immigration into the Northwest had also largely increased during the year; for the number of homestead entries last year were fifty per cent greater than the year before, and largely in advance of the figures for any previous year in the history of our great western domain. The statisticians of the United States say that the surplus wheat production of their country amounts now to about 150 million




