LOCAL NEWS

THE K. N. R.—Owing to the recent change of time in the I. C. R., the Kent Northern train will not reach Richibucto till three o'clock, standard—a half hour later than formerly.

ARRIVAL. - The barkentine "Parsee," of Windsor, N. S., 374 tons, Captain Mosher from Sligo, Ireland, arrived at this port Saturday. She will load for Geo. K. McLeod. Several other vessels are expected. One has been out over fifty days.

Bass Fishing .- Bass are reported very plentiful down the river. The small boys of the town have provided themselves with hooks and lines and have made good catches off the public wharf. Only the smaller ones, however, find their way this far up the river.

SALE POSTPONED. - The sale of the Buctouche and Moncton road advertised to take place last week, has teen again postponed till October 25th. Dr. DeBertram, Manager Evans and Geo. V. McInerney, M. P., left for Ottawa, Friday, on business connected with the road.

BARK AND RAILWAY TIES .- There is considerable activity just now at the various stations along the I. C. R., in Kent County, in the shipping of tanbark and railway ties. Large quantities have been got out during the season. Messrs. Sumner and Co., of Moncton, are the principal buyers.

SOCIAL DANCE.—A social dance was held in the Temperance Hall last Thursday evening. Despite the fact that the music was not all that could be desired, those in attendance managed to enjoy themselves until midnight. On Monday evening the music was much better, and dancing was kept up until after midnight. A very pleasant time was spent.

MR. BROWN'S FVIDENCE WANTED .-Mr. J. D. Phinney left Saturday, for Boston, to attend the equity case of the Joggins Railway Co. vs. the Merchant's Bank of Halifax and others. The evidence of Mr. John C. Brown is wanted in the case, and the present proceeding is to take his evidence under commission. Mr. W. H. Fry, by whom the evidence will be taken, Attorney General Blair and Messrs. Wells, Q. C., Pugsley, Q. C., and Powell will be in attendance.

PROPOSED JUDICATURE ACT .- Copies of a judicature act, which it is proposed to introduce at the next session of the local legislature, have been sent to members of the legal profession with a request for suggestions on the principle and provisions of the bill. The act is largely based on that in force in .Ontario at present, with some provisions from the English and Nova Scotia acts. It is very comprehensive and will revolutionize the practice in our courts if it should be adopted.

BICYCLE CRAZE.—The bicycle craze which struck this county some time ago shows no signs of dying out. A party of bicyclists from Harcourt visited this town a few days ago, and now several of our young men are talking of providing themselves with wheels. The party was composed of Messrs. J. W. Miller, Walter Crocker, W. G. Thurbur, James G. Miller and W. V. Goodwin. The journey from Harcourt (30 miles) was made in less than four hours. Next morning they chartered the steam yacht Calluna to take them as far as Brown's yard on their return trip.

kindsto A FURTHER DELAY .- By a recent change in the I. C. R. time table, the northern express does not reach Harcourt until nearly six o'clock in the morning. The express from the south arrives in the evening, but the Richibucto mail waits for the northern train and thus does not reach Richibucto until nearly noon the next day. The inconvenience caused to the people of this locality by this arrangement has been repeatedly called to the attention of Inspector King, but so far he has made no change. The K. N. R train arrives less than four hours after the stage, and arrangements which would leave the northern mail to come by train would be much more acceptable to the people of Richibucto and Kingston.

-The Canadian Presbyterian church records a story of work in the foreign fields that is very encouraging. Few modern missions have met with more success than the mission on the island of Formosa. In that province, to which a few years ago one missionary went at the risk of his life, there are now 56 resident missionaries, beside native preachers, Bible women, students, etc., and in over 50 chavels the Work is regularly preached. From Trinidad accounts are just as interesting, and in the district of the New Hebrides worked by the Canadian church, the wo.k is increasing year by year.-Truro News.

-When a reporter met some of the crew of sch. Gladstone to-day they had a genuine fish story to tell. On the voyage around from Sydney, and while on La Have bank, a monster codfish was hooked. The fish gave the captain quite a lot of sport before it was captured, and when the fish was fully mastered, in order to get it on deck, a chain hook was fastened to the staysail halyards, and it took two men some time to get it aboard. The fish was nearly seven feet in length and girded twenty-eight and a half inches. The head filled a 40-lb. butter tub. 
